FORM DBPR ABT – 6033 IS REQUIRED TO:

- Enter the annual quota beverage license drawing for establishing the order of priority in which license applications will be considered for an available quota license in a particular county pursuant to Section 561.19, Florida Statutes.

GENERAL INSTRUCTIONS

Format and Filing of Entry Form

All fields of the entry form must be completed. If a field is not applicable to the type of entry, insert "N/A." Each entry form must be typed or neatly printed in ink. Only properly completed entry forms will be accepted and included in the license drawing. A separate entry form must be filed for each county. A completed entry form, including payment (check or money order) may be submitted by mail to: Division of Alcoholic Beverages and Tobacco, Attn: Quota License Drawing, 2601 Blair Stone Road, Tallahassee, Florida 32399-1019.

Limitation on Number of Entries

An entrant, whether individual or business, may submit only one entry form per county. Person(s) directly or indirectly interested in the entity filing an entry form or in the business to be operated upon issuance of the license are subject to the limitation of one entry form per county. An entrant, therefore, may not be an entrant or interested person on more than one entry form in a single county, regardless of the type of entry submitted. Entry forms exceeding this limitation will be denied by the Division. Upon drawing of entrants, the Division will process a license application and issue a quota beverage license only to the person(s) listed on this entry form, provided the person(s) are qualified under the Florida Beverage Law.

Entry Period

Entry forms are accepted each year for a period of 45 days beginning on the third Monday in August. An entry form must be submitted before the deadline published in the Division's notice regarding the entry period, which is posted and available on the Division's website upon publication.

Entry Fee – Non-Refundable

The entry form must be accompanied by the entry fee of \$100 in the form of a check or money order payable to the Division of Alcoholic Beverages and Tobacco. If filing multiple entry forms, all applicable entry fees may be remitted in one lump payment. All entry fees are non-refundable.

Incomplete or Deficient Entry Forms

If the Division determines an entry form is incomplete, a deficiency letter will be mailed to entrant contact address on the entry form. The entrant will have fourteen (14) days from the date of the deficiency letter to make corrections to the drawing entry. If a corrected entry form is not received on or before fourteen (14) days from the date of the deficiency letter, the entry form will be denied.

SECTION	ADDITIONAL INSTRUCTIONS
Section 1: Type and Name of Drawing Entry	<p>Type of Drawing Entry Select the type of drawing entry based on the type of entrant filing the form. If filing an entry form as an individual in the name of a person, select "Individual Entry." If filing the entry form on behalf of a corporation or other legal entity in the name of the corporation or legal entity, select "Business Entry."</p> <p>Name of Drawing Entry Provide the name of the entrant, whether individual or legal entity, below the type of entry selected.</p>
Section 2: County of Drawing Entry	<p>County of Drawing Entry Review the Division's published notice regarding counties where licenses are available for the current entry period, which is available through the Division's website upon publication. Enter the name of the county in Florida where the entrant is interested in applying for and obtaining a quota alcoholic beverage license. Only one county may be listed on each entry form.</p>
Section 3: Entrant Contact Information	<p>Entrant Contact Information Provide accurate and legible contact information for the entrant who is authorized to receive and respond to correspondence from the Division during the processing of the entry form. All correspondence related to the entry will be sent to the mailing address provided in Section 3. If the entrant's mailing address changes prior to the drawing date, the entrant is responsible for notifying the Division of the updated address.</p>
Section 4: Interested Persons	<p>Interested Persons Full names and dates of birth must be included for all interested persons disclosed on the entry form. Each individual entrant and each business entrant must disclose all persons having a direct or indirect interest in the license to be issued or in the legal entity for which the entry is filed. A person interested in the license includes, but is not limited to, any person who has: a financial arrangement through joint funds with the entrant; an investment in the entrant's business or acquisition of the license; an obligation as a co-signor or guarantor of a note or lease related to the entrant's business or the acquisition of the license; taken any action that creates funds to enable a transaction or the operation of the entrant's business. Interested persons may include domestic partners, spouses, officers, directors, stockholders, limited and general partners, corporations or other legal entities, or any other entity having an interest in the license to be issued or in the legal entity for which the entry is filed.</p>
Section 5: Affirmation of Drawing Entrant(s)	<p>Affirmation of Drawing Entrants Review the affirmation statement in Section 5 before signing the entry form. Any person who files false information on an entry form may be prosecuted and denied entry in the drawing. Additional pages may be attached to the entry form to accommodate additional affirmation signatures if necessary.</p> <p>For an Individual Entry: Each person disclosed in Section 4 must provide an original signature of affirmation in Section 5. Any entry form which reflects a signature entered on behalf of an interested person must be accompanied by a notarized Power of Attorney record which affirms the signature authority.</p> <p>For a Business Entry: At least one individual disclosed on the entry form who is authorized to act on behalf of the legal entity must provide an original signature of affirmation in Section 5.</p>
