QUOTA LICENSE DRAWING ENTRY FORM

**GENERAL INSTRUCTIONS**

*You may wish to read 561.19, F.S., which regulates the issuance of new quota licenses.*

This entry form must be typed or neatly printed in ink and all questions answered. Only properly completed entry forms will be accepted and included in the drawing for the right to apply for a quota license. If you win the right to apply for a quota license, please note this is part one (1) of a two (2)-part process. The division will accept entry forms and award licenses (part 2) only to those persons listed on this entry form, provided those persons are qualified under the beverage laws.

**Only one entry form** per person(s) directly or indirectly (financially) interested in the license or licensed business is authorized for inclusion in the drawing. (For example: submitting two entry forms, one as an individual and another as part of a corporation, will result in one of the entry forms being denied.) **A NON-REFUNDABLE filing fee of \$100 is required and must accompany each entry form.** **The \$100 filing fee will not be refunded for any reason.** Please be sure that you thoroughly read and understand the AFFIRMATION section before you sign this entry form. Persons filing a false entry form or information may be prosecuted and their entry form denied.

The division will accept entry forms for **45** days beginning **December 27, 2011**. The division must receive all entry forms at the below address by **5:00 p.m. on February 9, 2012**. **No exceptions**. Mail the completed entry form, including payment (check or money order made payable to the division), to: **DIVISION OF ALCOHOLIC BEVERAGES AND TOBACCO, Attention: Quota License Drawing, 1940 North Monroe Street, Tallahassee, Florida 32399-1021**.

If your entry form is incomplete, you will receive a deficiency letter and will have fourteen (14) days from the date we mail the deficiency letter to correct your entry form. The division must receive your corrected entry form prior to the fourteen (14) day deadline or your entry form will be denied. **If the required filing fee is not included with your entry form, or if the funds submitted as payment for entry is deemed to be insufficient after the deadline for filing, the entry form WILL not be included in the drawing.**

**ENTRY FORM INSTRUCTIONS**

- A. The name of each individual entrant, corporate officer, directly or indirectly interested person, etc. is required to be entered in Part B. A person "Interested" in the license or licensed business includes, but is not limited to, a person who agrees to do any of the following: enter into any financial arrangement through joint funds, investing funds, cosigning or guaranteeing a note or lease, or any action that creates funds for a transaction or the ability of the business to operate. This may include Spouse, Officer(s), Director(s), Stockholder(s), Chief Executive, Limited and General Partner(s), Corporation(s), or any other entity connected with the business. **The date of birth must be included for all persons listed on the entry form.**
- B. If the applicant is a corporation or other legal entity, complete Part C.
- C. The division will mail all correspondence to the address listed in Part D. It is **your** responsibility to ensure the division has your current mailing address at all times by notifying the division by e-mail, or in writing via fax or at the mailing address above.

You may attach additional pages if necessary. If you attach additional pages, you should indicate that you have done so in the corresponding section of the entry form.

**SIGNATURES**

**The entry form must include the original signature of each person listed in Part B.** If you are signing for another person, a **notarized Power-of-Attorney giving you that authority must be included with this entry form.** If you filled out Part C, only the signature of an authorized individual(s) is required.

**Note: We encourage you to file your entry form as early in the 45-day period as possible. This will give us the ability to review it and address deficiencies more quickly. We believe this will also decrease the time between the end of the 45-day period and when the drawing will occur.**
