PART I: CERTIFICATE OF PACKAGE RETURNS TO MANUFACTURERS

All returns to manufacturers must be accompanied by applicable manufacturers' affidavits of product return.

PART II: CERTIFICATE OF STAMP DESTRUCTION BY DIVISION

All stamp destructions must be witnessed by a representative from the Division of Alcoholic Beverages and Tobacco.

Table with columns for 20s, 25s, s and a column for List description/reason for stamp destruction.

PART III: TAX COMPUTATION

Tax credits and refunds are calculated at the net of the applicable tax rate, less the CWD 2% discount on the par value of the stamp, up to the first \$0.24 per package.

PART IV: SIGNATURES

Signature of CWD representative is required for product returns and stamp destructions, and signature of AB&T representative is required for all stamp destructions.
