

INFORMATIONAL PACKET FOR COMPLETING DIVISION OF ALCOHOLIC BEVERAGES AND TOBACCO APPLICATIONS

If you have any questions or need assistance, please contact the Department of Business and Professional Regulation or your local district office.

This informational packet provides fee information for the most commonly issued licenses and contact information for each district office. Our goal is to provide useful information to aid you in filling out your application(s).

When you have completed your application packet and obtained all the required approvals, you will need to do one of the following:

- 1. Mail in the application.**
- 2. Drop off the application.**
- 3. Call the district office serving your area of interest to make an appointment.**

Applications mailed in or dropped off may not be processed on the same day as received; however, they will be reviewed within seven working days. You will be notified in writing if any additional information is needed. Applications must be submitted in duplicate (**1 original and 1 copy is preferred**) and must be typed or neatly and legibly printed in ink. We encourage you to make copies prior to your appointment. Failure to do so will result in a delay in processing time. Copies of documents made by this office will result in the following charges:

\$ 0.15 for one-sided documents

\$ 0.20 for two-sided documents

Fingerprints

Fingerprints must be submitted by each individual applicant, all corporate officers, all managing members, all general partners of a limited partnership, all partners of a general partnership, each individual stockholder owning more than .5 percent of stock, and all directors. Each applicant shall submit electronic fingerprints through the department's vendor PearsonVue. Costs associated with the fingerprint process will be collected by PearsonVue. You may contact PearsonVue at www.pearsonvue.com or by calling 1.888.274.2020. At the time application is made to the Division of Alcoholic Beverages and Tobacco, you will need to submit your PearsonVue receipt. The receipt serves as proof of the fingerprint requirement and includes information necessary to process your application. Failure to provide this receipt will delay the processing and/or denial of your application.

Note: If you are a current licensee or have been fingerprinted by this division in the past three (3) years, you are not required to submit this fingerprint information.

Please Note: If you file your application by appointment and wish to purchase a temporary license, if paying by cash, you must have exact change. This also applies to any applicable fingerprint fees.

Federal Regulations

Manufacturers, Wholesalers, Distributors and Retailers should be aware of federal regulations regarding the sale of alcoholic beverages and tobacco. The various federal agencies that regulate the alcohol and tobacco industries may be found on the Internet at <http://firstgov.gov/>. Specific agencies that deal with the regulation of alcohol and tobacco include the U.S. Treasury's Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), and the Alcohol and Tobacco Tax and Trade Bureau (TTB). Retailers should be aware of regulations involving an annual special occupational tax. Important Note if you are Applying for a Specialty, Club, or Quota License

Certain qualifications must be met and maintained in order to qualify for a specialty, club, or quota license. Please refer to the district office list below to ascertain which district office handles the county in which you wish to operate and the requirements for a specialty license in that county. The statute that authorizes the issuance of a specialty license and the qualifications for same is listed for each county covered by that office. Listed below are the most common specialty and club licenses. **The statutory authority and the wording below must be inserted in the section of the application labeled Special License Requirements.** If you are applying for a specialty or club license not listed, please see Ch. 561.20, Florida Statutes, or contact the office serving your area of interest for assistance.

Special Restaurant License:

Must maintain a bona fide restaurant consisting of [] square feet of floor space under a permanent cover, maintain seating and equipment for serving [] patrons at tables at one time, and which derives at least 51% of its gross revenue from the sale of food and non-alcoholic beverages. Service of full course meals must be available at all times alcoholic beverages are being served. No package sales of alcoholic beverages is permitted.

Special Hotel License:

Must maintain a bona fide hotel, motel, or motor court of not fewer than [] guest rooms which derives at least 51% of its gross revenue from the rental of hotel or motel rooms.

Special Condominium License:

Must maintain a condominium accommodation of which no fewer than [] condominium units are wholly rentable to transients and which is licensed under the provisions of chapter 509.

Special Bowling License:

Must own or lease a bowling establishment having 12 or more lanes and all necessary equipment to operate it. No package sales of alcoholic beverages is permitted.

Golf Club License:

Authority: 561.20(7)(b)

Must own or lease and maintain a bona fide standard golf course consisting of at least 9 holes, with clubhouse, locker rooms, and attendant golf facilities and comprising at least 35 acres of land owned or leased by the club.

Quota License:

Authority: 561.29((1)(i)

Must maintain the licensed premises in an active manner during regular and reasonable business hours for at least 8 hours a day for a period of 210 days or more during any 12 month period commencing not more than 6 months after acquisition of the license.

Special Boat License

Authority: 565.02(3)(a)

License must maintain at all times a pleasure, excursion, sightseeing, or charter boat with a Coast Guard approved capacity of at least 125 passengers. May sell and serve alcoholic beverages during a period of no longer than 1 hour prior to departure on a scheduled or chartered cruise while the boat is docked at a docking facility or marina and the period which the boat is in operation on the scheduled or chartered cruise for consumption on the premises only.

Special Restaurant Licenses

Broward County licenses are issued pursuant to Florida Statute 561.20(2)(b) to establishments that maintain a bona fide restaurant having 4,000 square feet of floor space under permanent cover, seating for 200 patrons, and deriving 51% of their gross revenue from the sale of food and non-alcoholic beverages.

Broward County licenses are issued pursuant to Florida Statute 561.20(2)(b) to establishments that maintain a bona fide restaurant having 2,500 square feet of floor space under permanent cover, seating for 150 patrons, and deriving 51% of their gross revenue from the sale of food and non-alcoholic beverages. The premises must be located in a specialty center on governmentally owned land comprising at least 50,000 square feet of leasable area.

Special Hotel Licenses

Broward County licenses are issued pursuant to Florida Statute 561.20(2)(b) to hotels, motels, and motor courts having not fewer than 50 guestrooms and deriving 51% of their gross revenue from the rental of rooms.

Licenses in Historical Districts are issued pursuant to Florida Statute 561.20(2)(a)1 to hotels, motels, and motor courts having fewer than 100 guest rooms and deriving 51% of their gross revenue from the rental of rooms. The premises must be listed on the National Register of Historic Places.

Club Licenses

1. Subordinate lodges or clubs of national fraternal or benevolent associations;
2. Golf clubs, tennis clubs, and beach or cabana clubs which are municipally or privately owned or leased;
3. Nonprofit corporations or clubs devoted to promoting community, municipal, or county development or any phase of community, municipal, or county development;
4. Clubs fostering and promoting the general welfare and prosperity of members of showmen and amusement enterprises;
5. Clubs assisting, promoting, and developing subordinate lodges or clubs of national fraternal or benevolent associations; and
6. Clubs promoting, developing, and maintaining cultural relations of people of the same nationality.

Special Restaurant Licenses

Charlotte, Collier, Glades, Lee, Manatee and Sarasota County: Licenses are issued pursuant to Florida Statute 561.20(2)(a)4 to establishments that maintain a bona fide restaurant having 2,500 square feet of floor space under permanent cover, seating for 150 patrons, and 51% of their gross revenue from the sale of food and non-alcoholic beverages.

Hendry County: Licenses are issued pursuant to 71-660, Special Act, to establishments that maintain a bona fide restaurant having 4,000 square feet of floor space under permanent cover, seating for 200 patrons, and 51% of their gross revenue from the sale of food and non-alcoholic beverages.

Special Hotel Licenses

Charlotte, Collier, Hendry, and Lee County: Licenses are issued pursuant to Florida Statute 561.20(2)(a)1 to hotels, motels, and motor courts having not fewer than 100 guestrooms and deriving 51% of their gross revenue from the rental of rooms.

Glades County: Licenses are issued pursuant to Florida Statute 561.20(2)(a)1 to hotels, motels, and motor courts having not fewer than 80 guestrooms and deriving 51% of their gross revenue from the rental of rooms.

Club Licenses

1. Subordinate lodges or clubs of national fraternal or benevolent associations;
2. Golf clubs, tennis clubs, and beach or cabana clubs which are municipally or privately owned or leased;
3. Nonprofit corporations or clubs devoted to promoting community, municipal, or county development or any phase of community, municipal, or county development;
4. Clubs fostering and promoting the general welfare and prosperity of members of showmen and amusement enterprises;
5. Clubs assisting, promoting, and developing subordinate lodges or clubs of national fraternal or benevolent associations; an
6. Clubs promoting, developing, and maintaining cultural relations of people of the same nationality.
