Pursuant to 561.695(5), Florida Statutes, after the initial designation, to continue to qualify as a stand-alone bar the licensee must provide to the division annually, on or before the licensee’s annual renewal date, an affidavit certifying, with respect to the preceding 12-month period, the following:

- (a) no more than 10% of the gross revenue of the business is from the sale of food consumed on the licensed premises as defined in s. 386.203 (11);
- (b) other than customary bar snacks, as defined by division rule, the licensed vendor does not provide or serve food to a person on the licensed premises without requiring the person to pay a separately stated charge for food that reasonably approximates the retail value of the food;
- (c) the licensed vendor has conspicuously posted signs at each entrance to the establishment stating that smoking is permitted in the establishment.
