Motion was made by Mr. Dennis, seconded by Mr. Platau, to ratify Annual Regulatory Plan. Upon vote, motion was passed unanimously.

#### B. Rules Report- Sr. Assistant Attorney General

Ms. Munson reported that this was an informational item only.

#### C. Rules correction for overview

Rule 61H1-27.002 (4)(a) Concentrations in Accounting and Business

Motion was made by Mr. Dennis, seconded by Mr. Platau, to amend and redefine upper division as courses above the principle or elementary level. All other previous language to be stricken. Upon vote, the motion passed unanimously. Motion was made by Mr. Dennis, seconded by Ms. Keegan, that the proposed rule would not have an adverse impact on small businesses or likely to directly or indirectly increase regulatory cost to any entity (including government in excess of \$200,000 in the aggregate in Florida within (1) year after the implementation of the rule. Motion was made by Mr. Dennis, seconded by Ms. Keegan, that the violation of this rule does not constitute a minor violation. Upon vote, the motion was passed unanimously.

Ms. Munson discussed briefly on the Auditor Draft Rules revised and summary changes. Mr. Dennis asked Mr. Thames to speak to the Board on the regulations, provisions and laws that are on the website and the language used in the law regarding CPA professional standards.

## C. Resolution to Steve Vogel

Motion was made by Mr. Dennis, seconded by Mr. Platau, to approve resolution for Mr. Vogel. Upon vote, motion was passed unanimously. In further discussion the Board thanked Mr. Vogel for the years of contribution, dedication and service to the Board.

#### D. Remarks from the Executive Director

Mr. Scarborough thanked all the Board members for all of their help as he transitions into his new role as Executive Director. Mr. Scarborough shared with the Board that we have some very experienced staff that could potentially retire in the near further. As a result, he has taken steps to improve our document storage practices and next, he plans to focus on updating our written procedures.

Mr. Scarborough explained to the Board that each committee now has a staff liaison to act as a contact person for each committee. The staff liaison should be introducing themselves to the committee chair and is available to supply information when needed.

Ms. Keegan had inquired about Board training for the new incoming Board members and after discussion with Mr. Scarborough they have decided to add new Board member training to the December agenda after the Probable Cause meeting and asked to extend an invitation to the current and exiting Board members as well.

E. Update from Board Member/Staff serving on NASBA Committees

# 19. Florida Institute of Certified Public Accounting (FICPA)

Mr. Thames reported that the FICPA is moving forward on the correct way to address a "Retired" status. Mr. Thames shared with the Board members regarding a bill that the FICPA is working on involving policy considerations for ethics and CPE reciprocity and how it could be implemented in Florida. If you have a license in Florida, the licensee will have to take a Florida specific ethics courses that are required regardless if Florida is their home state or not. Mr. Thames spoke on the Licensure by Endorsement potential loophole that needs to be adjusted to make it clear that you must be licensed in another state to qualify for Licensure by Endorsement. Mr. Thames shared with the Board that questions had been posed during CPE Committee meetings regarding course content in some of the ethics courses that are being provided and or approved. Mr. Thames stated the FICPA is going to send out more information with further detail on the courses that are acceptable. Mr. Thames understands that the language is somewhat vague. Mr. Thames stated that the FICPA will improve the language to give clarity.

#### 20. Old Business

#### 21. Other Business

Motion was made by Mr. Jesus Socorro, seconded by Mr. Dennis, to approve the appointment of Roger Scarborough as the new Executive Director. Upon vote, the motion was passed unanimously.

Mr. Dennis pointed out that in that in recent history, all of the cases before the Probable Cause Panel involving only a CPE deficiency of ethics, the panel has closed the case and issued a letter of guidance in lieu of a finding of probable cause. He raised the question whether the board would desire the Probable Cause Panel to be more or less strict in these instances. He asked for guidance from the Board.

Mr. Thames pointed out that the Florida Ethics course is required by statute and largely focused on Florida law and administrative rules. He encouraged the Board to enforce the rule by disciplining CPAs for failure to take the Florida ethics course. In response to a question, Attorney Brande Miller shared that a letter of guidance does not require people to take the ethics class, however the Board's practice has been to issue a letter of guidance in cases where the licensee has completed the ethics course prior to the Probable Cause Panel meeting. Mrs. Miller also shared that it's the Board's practice not to offer a letter of guidance to a repeat offender.

After much discussion, the Board conveyed its goal is for the licensee to take the ethics course and that the Panel should consider each case on its merit with the Board open to findings of probable cause in cases where the only issue was a lack of an ethics CPE course.
