### E. Remarks from Executive Director

Mr. Scarborough shared with the Board information regarding Discipline; summarizing that most licensees under disciplinary actions do what is required of them. He surveyed the CPE discipline cases with final orders issued between July 1, 2016 and June 30, 2017, resulting in 68 cases. Of those, one licensee passed away and in 48 of the 68 cases, the licensee had done what was required. Of the remaining 19 cases, 6 had been suspended, 1 revoked and 10 converted to null & void all of which result in the Division loosing most of our leverage for compliance.

Mr. Scarborough shared Mr. Platau's inquiry regarding the DBPR phone system and his remarks that it is difficult to get past the DBPR call center in Tallahassee to the CPA Board office in Gainesville. Mr. Scarborough is researching the call volume to determine whether the Board office should publish the office number and whether the board has the resources to process the potential resulting call volume.

# 13. Update from Board Members Serving on the NASBA Committees

Mr. Platau informed the Board that he was still serving on the NASBA Committee, Dr. Fennema is continuing to serve on the ICRIB Committee and Mr. Skup will continue to serve on the CPA Exam Committee.

# 14. Florida Institute of Certified Public Accounting (FICPA)

Ms. Curry recapped the upcoming Legislative Session and the bills affecting the CPA profession directly. Ms. Curry shared the Deregulation Bill (Senate Bill 474) sponsored by Senator Ben Albritton, known as the Occupational Freedom and Opportunity Act. This Bill seeks to deregulate several of the professions, addresses CPE requirements by licensees coming into the state and CPE licensure by endorsement. Ms. Curry also discussed the Sunset Bill (House Bill 707) sponsored by Representative Paul Renner. This bill creates the Occupational Regulation Sunset Act. This bill requires regulatory boards to take a good look at their processes and the Legislature will perform a review of cost and benefits of each Occupational and Regulatory program. Ms. Curry spoke on House Bill 473 which will include language adding a "Retired" CPA status.
