Mr. Shierling requests that the denial letters mailed to applicants be placed in front of each applicant agenda materials for easier review, for staff to consider a final deadline of additional materials received from applicants to at least one to two weeks prior to meeting to allow sufficient time for review, recommend for staff to lobby to the legislature, in order to carry over funds from previous year, to current award year, due to the excess number of scholarship applications being received and could have used the money this year for funding. Director Veloria Kelly indicated that would require a statutory change and Justin Thames from the FICPA indicated that would be a good opportunity to discuss with Chair Vogel of the legislative subcommittee in order to get the boards support. Mrs. Borders-Byrd inquired if it is too late to get item on the legislative committee meeting coming up soon and Director Kelly indicated that she will make sure that the item will be placed on the agenda. Justin Thames of the FICPA also indicated that the ethnicity data from the statistics is good data to provide in order to be successful in lobbying for funds.
