Director Kelly indicated that she would ask the Office of the Secretary to mention the scholarship in his speaking engagement this year. Ms. Ashley Hill asked if we have thought about making the application process electronic. She stated maybe if it was electronic it may encourage more participation or we may receive more applications. Director Kelly informed them that staff has been working on an electronic agenda and the systems allow the applicant to apply, upload transcripts, and letters of recommendations. Director Kelly indicated that it will take us talking with technology a bit more because she is sure that the system we currently have does not allow someone to submit information on behalf of the applicant. Ms. Hill requested that staff send the advertisement information out to the Committee as well, so that they can push it out to different organizations in which they are a part of who may have connections with students. Mr. Shierling stated that maybe Justin Thames, FICPA could work with the FICPA in getting the word out to the Chapters, so that they can contact the schools in their area to remind them of the scholarship. Mr. Thames indicated that he would be able to do that and also informed the Committee that the FICPA push out the scholarship information in their social media and newsletter. Director Kelly informed the committee that board staff would also send the advertisement flyer to the Accounting Education Committee who typically meets four times a year in which Dr. Fennema is the chair and there are other educators that serves on the board on that committee, who can get the word out about the scholarship.
