MINUTES

The meeting was called to order at 10:39 a.m. by William Blend, Chair. The roll was called reflecting the following:

Ratify Minutes from April 21, 2021 meeting

Motion was made by Dr. Laursen and seconded by Mr. Session to approve the minutes from the April 21, 2021 meeting. Upon vote, motion passed unanimously.

Mr. Blend addressed the recently passed bill regarding the four hours of ethics and the potential interpretation of that statute and what it means that a majority of the course hours has to be on Florida laws and rules. Mr. Blend asked that Ms. Munson give them some general information on the topic and then he would open it up for the Committee members to discuss.

Ms. Munson inquired of Mr. Scarborough as to whether the law had been signed by the Governor. Mr. Scarborough confirmed that the bill had not been signed by the Governor yet. Ms. Munson informed the Committee that we are required to operate under existing rules and any pending changes or anticipated changes that are not yet legally in effect does not govern this particular moment in time. Ms. Munson informed Mr. Blend that legally she could not direct them to follow the new law knowing that it is not yet in effect or when it will be in effect. She stressed the committee is confined to the existing law.

The Committee inquired if there was anything in the new proposed law that indicates how many questions must be on the final exam.

Ms. Munson informed them that the law does not mention the questions and only reference the hours of the course. She informed them that as a Division they would have to review the bill to see how to best apply it.

Mr. Scarborough opined that if more than fifty percent of the questions on the exam were related to F.S. Sections 455, 473 and the related rules, the exam would be a good indicator that the provider was making an effort to meet the requirements of the statute.

Mr. Thames shared that the bill was presented to the Governor on Monday and he has fifteen days to sign the bill into law or veto it. If he does not take any action within the fifteen days, the law will take effect July 1st.

Concerns were expressed over the bill taking effect immediately and impacting providers' ability to offer the course. Mr. Thames shared his understanding was that any courses that were approved today could be offered during the coming reestablishment period but that courses approved after the law went into effect would have to meet the new statutory requirement. Ms. Munson agreed with Mr. Thames statement.

Committee members encouraged staff to give guidance to the providers regarding the change in law.

A member suggested that as the Board looks into the new law and considers future rulemaking that we require providers to pull information from the current rules of the

Florida Board of Accountancy and that their course material identify the year of the rules they are referencing.

Ms. Munson agreed that the committee should consider language in the rule that providers are expected to include the most recent version of the laws and rules.

Dr. Laursen suggested for the 20 questions that we want for self-study courses that we indicate how many of those questions should be on Florida laws and rules.

Mr. Scarborough informed the Committee there is another section of the bill that addresses Florida CPAs who are non-Florida residents satisfying their Florida CPE requirements by fulfilling the requirements in their home state <u>and</u> taking a Florida approved ethics course.

In response to a request, the committee confirmed to Mr. Scarborough their desire for the board to require more than fifty percent of the questions on a self-study ethics course pertain to the Florida laws and rules.
