Consider Ethics Provider and Course Application:

a. MY-CPE LLC

1. Ethical Conduct for Florida CPAs – Self-Study – 4 CPE hours

Motion was made by Ms. Caldwell and seconded by Ms. Rankin to approve the course listed above. Upon vote, motion passed unanimously.

Renewal Ethics Provider and Course Applications:

- a. Furthered, Inc.
 - 1. A Basic Ethics Guidebook for Florida CPAs Self-Study 4 CPE hours

The Committee informed the provider that they need to have the author confirm that the course material has been updated at least through 2023 and submit an updated copy of the course. The Committee also informed the provider that they need to provide documentation showing that a minimum of eighty percent is required for Florida CPAs to pass the final exam. Upon vote, motion passed unanimously.

2. Ethical Conduct for Florida CPA – Self-Study – 4 CPE hours

Motion was made by Ms. Camp and seconded by Mr. Dennis to approve the course listed above pending the provider submit documentation showing that a minimum of eighty percent is required for Florida CPAs to pass the final exam. Upon vote, motion passed unanimously.

 - Mr. Scarborough informed the Committee that if they agreed with staff creating the form, he would move forward with it and present a copy of the form to the Committee at their next meeting.

The Committee agreed for staff to move forward with creating the form.
