Directors Message

Have you heard of the CPA Evolution initiative? Are you aware that the Uniform CPA Examination (CPA Exam) is changing significantly in January 2024? If you work with potential exam candidates or mentor a person expecting to take the exam, it is important that you learn about this initiative and the upcoming changes to the CPA Exam to fully understand how it might impact their journey to CPA licensure. If they pass and retain credit for all four CPA Exam sections by December 31, 2023, the changes to the CPA Exam will NOT impact their journey. If they will still be working their way through the CPA Exam in January 2024 and beyond, then the information about the CPA Evolution-aligned CPA Exam (the 2024 CPA Exam) and transition policy are most important to understand.

The role of today's CPA has evolved, and newly licensed CPAs are taking on increased responsibilities that were traditionally assigned to more experienced staff. Becoming a CPA means you'll need greater skill sets and competencies and a greater knowledge of emerging technologies. That is why the CPA Evolution initiative is underway. It is a joint effort of the National Association of State Boards of Accountancy (NASBA) and the American Institute of Certified Public Accountants (AICPA).

The new CPA licensure and CPA Exam model is a Core + Discipline model. The model starts with a robust core in accounting, auditing and tax that all candidates will have to complete. Then, each candidate must choose a Discipline section in which to demonstrate greater

skills and knowledge. Technology knowledge and skills will be tested in all sections, as it pertains to each section. Regardless of a candidate's chosen discipline, this model leads to a full CPA license, with rights and privileges consistent with any other CPA. The Discipline section selected for testing does not mean the CPA is limited to that practice area. The new disciplines reflect three pillars of the CPA profession:

- Business analysis and reporting (BAR)
- Information systems and controls (ISC)
- Tax compliance and planning (TCP)

If you know someone who is anticipating continuing their CPA Exam journey into 2024 and beyond, the much-anticipated transition policy is important news. This policy lays out how CPA Exam sections passed under the current CPA Exam map to credit under the 2024 CPA Exam. Transition policies like this have been necessary at other times when significant changes were made to the CPA Exam, such as when it was computerized in April 2004.

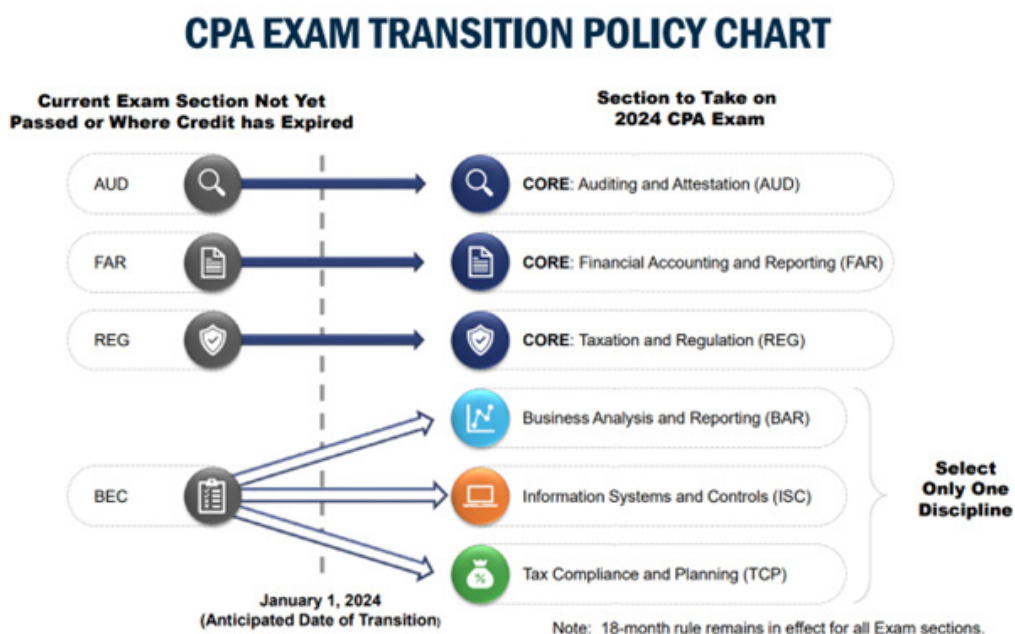
The policy was recommended to the Boards of Accountancy by the NASBA CBT Administration Committee after development and much deliberation by a task force with state board representatives from the AICPA Board of Examiners, sitting state board members and executive directors from multiple states. Because of the significant differences in the current and 2024 CPA Exams and the overall CPA licensure model, a perfect transition is not possible. The Boards of Accountancy have agreed this transition policy best serves the candidates, the state boards and the public interest.

The transition policy is quite simple. Candidates who have credit for AUD, FAR or REG on the current CPA Exam will not need to take the corresponding new core section of AUD, FAR or REG on the 2024 CPA Exam. Candidates who have credit for BEC on the current CPA Exam will not need to take any of the three discipline sections.

If, however, a candidate loses credit for AUD, FAR or REG after December 31, 2023, they then must take the corresponding new Core section of AUD, FAR or REG. A candidate who loses credit for BEC after December 31, 2023, must select one of the three Discipline sections to be tested. It is important to note that none of the sections of the current CPA Exam will be available for testing after December 31, 2023. There is a hard cutoff from the current CPA Exam sections to the 2024 CPA Exam sections on the January 2024 launch.

The CPA profession is at an exciting juncture as it moves to the CPA Evolution model. To

prepare for the 2024 CPA Exam launch, the Exposure Draft of the 2024 CPA Exam, which includes the draft Blueprints, will be released by the AICPA on July 1, 2022, and will outline the content and skills proposed for each section of the 2024 CPA Exam. The 2024 CPA Exam Final Report, which will include the final Blueprints, is scheduled to be released in January 2023, a year before the 2024 CPA Exam launches. The Chair's Corner

CPAs, like all licensed professionals, are required to complete continuing education courses. For CPAs, the legislature codifies the requirement in Florida Statutes Chapter 473 §473.312 and your Board of Accountancy promulgates rules under Chapter 61-H1-33 of the Florida Administrative Code. At the heart of the CPE requirement is that licensed professions must both show initial competence demonstrated by successful completion of an examination coupled with experience to gain entry to the licensed profession. After gaining entry into the profession, the licensee must remain current with developments in the field of licensure.

Each year on June 30, about half the licensed CPAs in Florida must demonstrate completion of their bi-annual 80 hours of continuing education courses. Of those 80 hours, four hours must be a **Florida Board Approved Ethics Course**. Recently, a modification to Chapter 473 further clarified the Legislature's mandate that "a

majority of the hours shall include a review of the provisions of Chapter 455 and this Chapter (473) and the related administrative rules." Not just any course in ethics will satisfy the statutory requirement that the ethics course be a Florida Board Approved Ethics Course. Chapter 455, Chapter 473 and the Board's Rules in Chapter 61-H1 of the Florida Administrative Code must constitute at least half of the Florida Board Approved Ethics Course hours.

Today there are 38 Florida Board Approved Ethics Courses. Providers range from native Florida providers such as the Florida Institute of CPAs (FICPA) and Gleim Publications, Inc., to national providers customizing courses specifically for Florida such as Western CPE and Becker Professional Education. With great regularity we see Florida CPAs who complete courses that do not comply with the statute. The Legislature has made it clear that Florida CPAs are required to take bi-annually at least two hours (of the four-hour ethics requirement) in the study of Florida's statutes and rules.

Your Board, along with the Board's Continuing Professional Education Committee, labor long hours to properly vet and approve courses that comply with the statutory requirements. There is no shortage of those courses or willing Board-approved providers.

As the deadline for CPE coursework completion approaches for about half our licensees, double checking to make certain that the **Florida Board Approved Ethics Course** has been properly completed will help ensure that licensees stay in compliance with the statutes regulating our profession.
