ORDER

Petitioner, Pedro F. Ruiz, filed a petition for a permanent waiver of the requirements of Rules 61H1-27.001(5)(a) and 61H1-27.002(3)(a), Florida Administrative Code (FAC), on March 2, 2010. The notice of the petition appeared in the Florida Administrative Weekly on April 2, 2010, in Volume 36 Number 13; no comments by interested persons were received. The petition was heard at a duly-noticed public meeting of the Board of Accountancy on May 14, 2010, in Tampa, Florida. At the hearing on this matter, Petitioner was present and not represented by counsel; the Board was represented by Mary Ellen Clark, Assistant Attorney General.

STATEMENT OF RELEVANT FACTS

The facts relevant to the petition are as follows:

- 1. Petitioner is an applicant for the CPA licensure examination. Petitioner is a graduate of an unaccredited undergraduate institution. Petitioner's application did not meet the educational requirements based upon a deficiency of fifteen semester hours of graduate level courses, to include three semester hours of taxation, six semester hours of accounting and three semester hours of business law.
- 2. Petitioner has been employed in Cuba for more than twenty (20) years as a licensed accountant.
- 3. Rule 61H1-27.002(5)(a), FAC, provides that "a graduate of a four-year degree granting institution not accredited at the time the applicant's degree was received or at

the time of filing application will be deemed to be a graduate of a four-year accredited college and the applicant satisfactorily completes at least 15 semester or 22 quarter hours, or the equivalent in post-baccalaureate education at the accredited institution of which at least 9 semester or 13 quarter hours, including at least 3 semester or 4 quarter hours in taxation."

- 4. Rule 61H1-27.002 (3)(b), FAC, provides that in order to be eligible to take the licensure examination, an applicant shall have completed "24 semester or 36 quarter hours in general business education which shall include not less than the equivalent of 6 semester or 8 quarter hours in business law courses which shall include the coverage of the Uniform Commercial Code, contracts and torts."
- 5. Petitioner seeks a permanent waiver of Rules 61H1-27.001(5)(a) and 61H1-27.002(3)(a), FAC, in order that the Board may find he meets the educational requirements to sit for the CPA examination.

Grounds for Partial Approval and Denial

The Board determined that the petition for waiver should be partially approved and partially denied and voted to grant the waiver of Rule 61H1-27.001(5)(a), FAC, and deny the waiver of Rule 61H1-27.002(3)(b), FAC, on the following grounds:

- 6. Petitioner has established that the purpose of the underlying statute, Section 473.306(2), Florida Statutes (FS), would be met were he to be granted a waiver of Rule 61H1-27.001(5)(a), FAC. Petitioner has failed to establish that the purpose of the underlying statute, Section 473.306(3), FS, would be met we he to granted a waiver of Rule 61H1-27.002(3)(b), FAC.
 - 7. Petitioner has established further that the Board's application of Rule 61H1-

27.001(5)(a), FAC, to his circumstances would violate principles of fairness and would impose a substantial hardship on him. Petitioner has failed to establish that the Board's full application of Rule 61H1-27.002(3)(b), FAC, to his circumstances would violate principles of fairness and would impose a substantial hardship on him.

It is therefore **ORDERED** that the petition with regard to Rule 61H1-27.001(5)(a), FAC, be **GRANTED** and that the petition with regard to Rule 61H1-27.002(3)(b), FAC, be **DENIED**. Respondent shall be required to complete 6 semester or 8 quarter hours in business law courses which shall include the coverage of the Uniform Commercial Code, contracts and torts, to be eligible to sit for the CPA examination.

This Order shall become effective upon filing with the Clerk of the Department of Business and Professional Regulation.
