19 **TAB 2: Chair's Report – Gary Cacciatore, PharmD, JD**

20 Mr. Cacciatore stated elections for a Chair and Vice-Chair was discussed at the
21 last meeting. I will open the nominations for chair by any of the council
22 members.

24 Mr. Barnes asked don't we currently have a Vice Chair.
25

26 Mr. Cacciatore stated we do have a vice chair but it is not a succession type of
27 position. The Vice Chair takes over if the Chair is not able to attend the meetings.

29 Mr. Ellis nominated Mr. Cacciatore for Chair and Seconded by Mr. Mahoney.

32 Mr. Cacciatore stated nominations for Vice-Chair are now open.

34 Mr. Ellis nominated Mike Ayotte and seconded by Mr. Brock. Motion Carried.

38 **TAB 3: Executive Director's Report – Reginald Dixon**

39 **1. Rules Report:**
40

41 Mr. Dixon stated nothing has changed with rules since the last meeting. The
42 Division has been focusing on the DQSA and the Medical Gas legislation.
43

44 Mr. Cacciatore asked Mr. Dixon what has to be completed by October 1.
45

46 Mr. Dixon stated the Division is working on creating a Part 3 for Chapter 499
47 regarding Medical Gas instead of amending Chapter 499.
48
49

50 Mr. Dixon stated starting October 1, medical gas manufacturer and wholesale
51 permits that were limited to the state of Florida will now be allowed for out of
52 state. The division has been reviewing applications for any changes that need to
53 be made. Updating the website and putting in place any system changes.
54

55 Mr. Cacciatore asked Mr. Dixon if he had any knowledge of when the Federal
56 Guidelines will be coming from FDA.
57

58 Mr. Dixon stated he has not had any notification on FDA.
59

60 Mr. Dixon stated we have met with legislative staff and department staff in
61 regards to Drug Quality Security Act (DQSA). We are compiling a list of the
62 changes that need to be made to Chapter 499.
63

64 Mr. Dixon stated one of the issues to be resolved is in the DQSA it addresses
65 finished dose products and not active pharmaceutical ingredient (API).
66

67 Mr. Dixon stated the way Chapter 499 is written right now it has API and the
68 companies who wholesale API would have to pass a pedigree. The division has
69 to put some work into that. It will be a policy call from the Secretary on if API is
70 even a prescription drug.
71

72 Mr. Ellis stated that the Department has an opportunity to help small business in
73 the State of Florida with the bond amount.
74

75 Mr. Dixon stated under the DQSA you only have one bond for every state you do
76 business in.
77

78 Mr. Ellis stated but the state will have the option to change that amount
79 depending on the sales. I feel that is a great opportunity for small business.
80 I think we need to discuss this and perhaps talk to other small businesses.
81

82 Mr. Ellis also stated we need to identify the primary and secondary from the
83 website. In light of the federal legislation a secondary needs to know who the
84 primary wholesalers are.
85

86 Mr. Dixon stated that the Division had discussed adding a modifier to the
87 website. The division will research and provide a response at the next meeting.
88

89 Mr. Cacciatore suggested that we put together a committee to help with the re-
90 write of Chapter 499 in regards to DQSA.
91

92 Mr. Dixon stated the department would not be opposed to having a committee to
93 help in the rule making process for the DQSA. Some of you may have in-site to
94 what other states are doing.
95

96 Mr. Dixon stated the Federal regulations were supposed to be out by November.
97

98 Mr. Cacciatore stated perhaps we wait until the federal guidelines come out
99 before we suggest a committee.

2. *Controlled Substance Reporting*

Mr. Dixon provided a report to the council on the Controlled Substance Reporting.

Mr. Dixon stated there are issues with the CSR when trying to perform audits. The way legislation was written, there are entities that have one of the 5 permits that are required to report and have a DEA number. But they don't sell controlled substances so they don't have to report.

The department is in the process of rebuilding the CSR and the goal is for January 2015 to actually have something in place.

The division will be able to search on what drug was sent to a certain pharmacy. Hopefully be able to get accurate audit reports once complete.

Mr. Dixon stated the Declaratory Statements were provided to the council as informational purposes only.
