Changes Coming to License Applications

The Division is working on multiple changes relating to the Bureau of Elevator Safety license applications, including how applications are accepted, how permits are issued and managed, and collecting additional information. These improvements have started and will be completed within two years.

You may have already experienced one – how applications are accepted. The Division stopped accepting applications by email for any license that can be applied for online. Applications for permits to alter are not available online at this time and can be submitted by email, but they are printed and processed in the order received with applications received by mail. In the future, all applicants will be referred to the department's licensing portal as we work to have all applications available online, including permits to alter.

To enable online permits to alter, we need to change how we record and manage permits in our license management system. The planned improvement will increase control over permits and provide more public information about existing permits. Stay tuned for more information.

The third planned change will be happening within the next few months. We are adopting new forms to collect license mailing information separate from the owner information. This will allow the building management or contact person to receive license-related mail, while assigning ownership and legal responsibility to the elevator owner, as required by statute. Additionally, licenses will be issued to owners, with the building name and elevator designation (such as "A" or "1") being listed as a "DBA".

Direct Supervision Required by Statute, Defined in Rule

Florida law allows elevator personnel who are not licensed by the Division to construct, install, maintain or repair elevators in Florida, as long as they are under the direct supervision of a certificate of competency holder. These personnel working under direct supervision are called “elevator helpers” and are subject to the basic requirements of Florida law.

If someone is found constructing, installing, maintaining, or repairing an elevator without direct supervision, then that person is not an elevator helper, but is considered unlicensed elevator personnel. The Division issues citations, with fines up to \$1,000, for unlicensed activity to the person performing the work without the required license.

So, what is direct supervision? That term is defined in the Division’s administrative rules, specifically Rule 61C-5.008(7), Florida Administrative Code. According to that law, “direct supervision means a certificate of competency holder supervising an elevator helper as set forth in section 399.01(15), Florida Statutes, is within physical proximity of the person being directly supervised such that timely observation and evaluation of the work being performed is facilitated to ensure the work is completed in accordance with applicable statutory and administrative code requirements.”

WHAT THE LAW SAYS:

Section 399.001, Florida Statutes

... Elevator personnel performing work covered by the Florida Building Code must possess documented training or experience or both and be familiar with the operation and safety functions of the components and equipment. Training and experience includes, but is not limited to, recognizing the safety hazards and performing the procedures to which they are assigned in conformance with the requirements of the Florida Building Code.

Section 399.01, Florida Statutes

(15) “Elevator helper” means a natural person performing work under the direct supervision of an elevator certificate of competency holder to construct, install, maintain, or repair any vertical conveyance.

Navigating the Inspection Report - Violations

The following information is a brief overview only. For detailed information on inspection reports, please see the [Step by Step Instructions for Completing the Elevator Inspection Report](#) posted on our website.

The middle of the inspection report contains nine boxes to list the violations found during an inspection. This section must be filled out – both written and bubbled – to record and report any violation of the elevator safety codes and related Florida laws observed during any type of inspection.

Each violation box is identified as “Violation 1” through “Violation 9.” The violation is recorded in this section as an alphanumeric code containing one letter and three numbers. The letter indicates the type of elevator – E for electric, H for hydraulic, S for escalator, M for moving walk, and O for other. The three-digit code identifies the type of violation and is listed on the back of the inspection report.

The inspector writes the alphanumeric violation code in the blank space provided in the violation box and bubbles the corresponding letter and numbers. This bubbled code is used to record the violation into our license management system. If the code is not bubbled, the violation will not be recorded under the license record. The violation is described in the comments box, to be discussed in more detail in the October issue.

Hot Topic Q&A - Continuing Education Certificates

Q. What information is needed on a continuing education certificate to obtain credit for the hours?

A. Florida law requires an elevator continuing education certificate contain the following information: the time and date of the course session, name of the course, number of course hours attended, the course provider's name and provider number assigned by the department, the course instructor's name and signature, and the course identification number assigned by the department. Please review the certificate for the continuing education you have completed to make sure that it has *all* of the required information. If not, contact the course provider to obtain a corrected certificate.



Division Transitioning to Digital Inspections and New Report Form

For years, the Division's elevator inspectors have been recording inspection results on the same form that many in the industry use – DBPR Form HR 5023-003. However, we are now preparing to transition our inspectors to a digital inspection report that will be filled-out electronically on an iPad and printed in the field after it is completed. This new inspection report will be rolled-out to the field in stages, with a goal of statewide use by December 2017. Elevator owners and personnel will start seeing this new report form as early as July, depending upon their location in the state.

The sample form below shows the basic format of the Division's new inspection report. The final adopted report may differ slightly. New information that is not currently recorded on the inspection report will be provided on this report, including the reinspection date by which cited violations must be corrected, the owner name and building name, and the elevator license expiration date. Violations are noted as "OUT" of compliance, and specific violation descriptions are listed at the end of the report.

New Elevator Safety Code Coming Soon to an Elevator Near You

**ASME
A17.1-2013**



The Division adopts elevator safety codes in conjunction with the Florida Building Code. The 6th edition of the Florida Building Code will include the 2013 edition of the American Society for Mechanical Engineering (ASME) A17.1 code relating to elevators, escalators, and moving walks. This newer code includes on-site documentation for maintenance control programs (MCP) and allows authorities having jurisdiction to accept alternative testing without load for certain parts of the Category 5 test.

The Division is currently working on adopting the ASME A17.1-2013 code, effective December 31, 2017. The Division is also developing rules related to the MCP and alternative testing.
