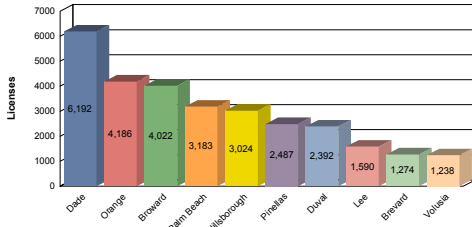

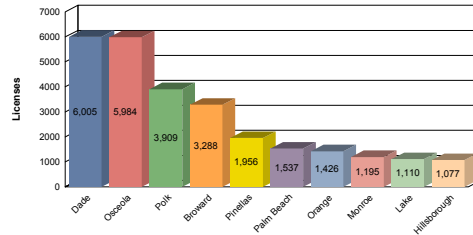

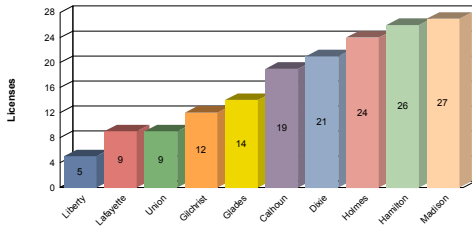
Most Food Licenses



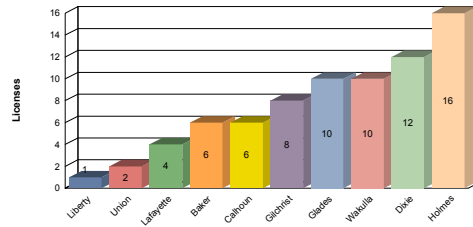
Most Lodging Licenses



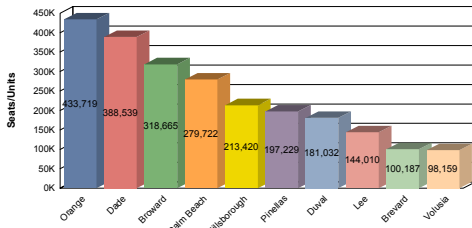
Least Food Licenses



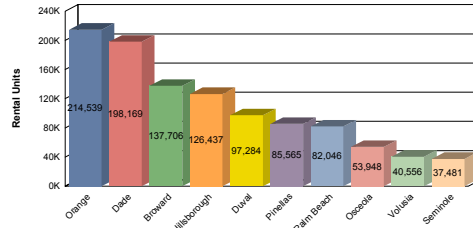
Least Lodging Licenses



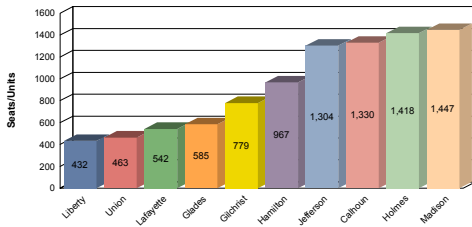
Most Food Seats/Units
