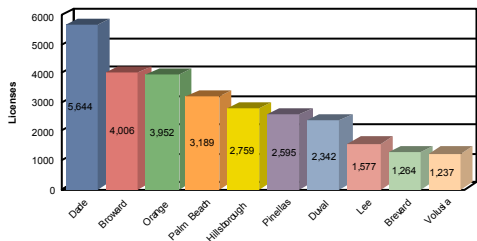

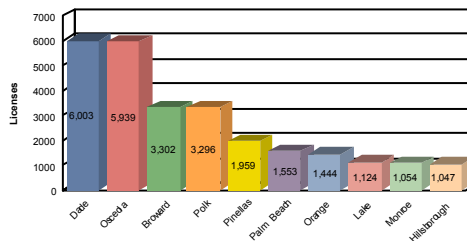

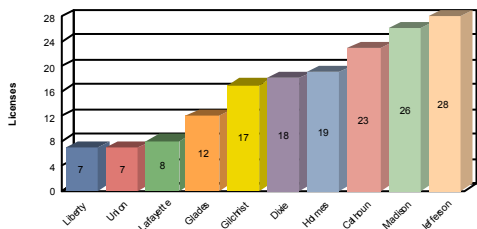
**Most Food Licenses**



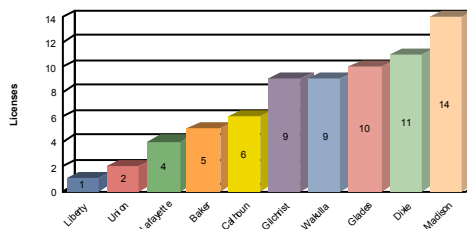
**Most Lodging Licenses**



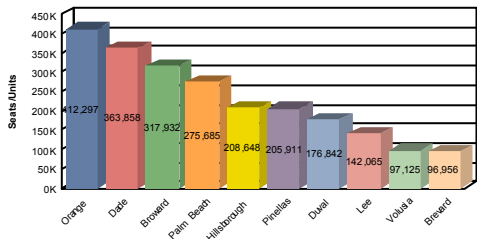
**Least Food Licenses**



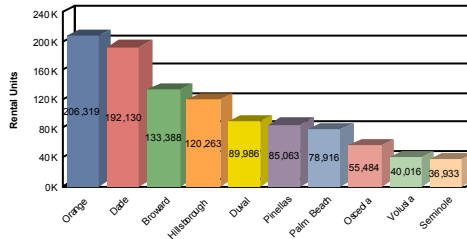

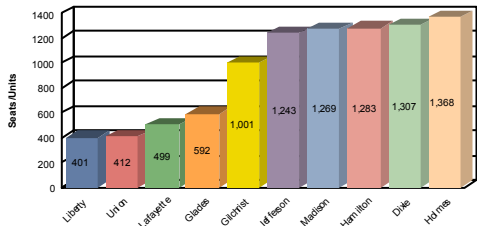
