61C-1.002	Adopted updated inspection and application forms; revised directives for rental unit and address changes made by the license holder of a vacation rental license; expanded the timeframe limit for requiring plan review when a food service establishment is reopened after being out of business from 12 to 18 months; and clarified when plan review is required. Filed for adoption on November 15, 2022.	December 5, 2022
61C-4.010	Establishes sanitation and safety measures, terms and other requirements related to the allowance of outdoor cooking equipment and outdoor kitchen equipment operated in conjunction with a licensed public food service establishment; and clarifies when plan review is required for outdoor equipment.
