IMPORTANT INFORMATION FOR ALL RENEWING BROKERS/SALEPERSONS

Licensing:

~~Pursuant to Sections 326.004(7)(b) and 326.004(8), F.S., all bonds and letters of credit shall be for the license period (two years), and a new bond or letter of credit or a proper continuation certificate shall be delivered to the division at the beginning of each license period to coincide with the license period.~~

~~Under Section 326.007(7)(d), F.S., a person may not be licensed as a broker unless he has been a salesperson for at least two years, and may not be licensed as a broker after October 1, 1990, unless he has been licensed as a salesperson for at least two consecutive years. Under Section 326.004(13)(b), F.S., each salesperson's license shall remain in the possession of the employing broker. Immediately upon the salesperson's withdrawal from the employing broker, the broker shall return the salesperson's license to the division for cancellation.~~

Escrow/Trust Accounts:

~~Pursuant to Rule 61B-60.006(1), F.A.C., a broker holding the license of a salesperson shall sign the closing statement of any transaction brokered by the salesperson.~~

~~Under Rule 61B-60.006(3), F.A.C., within three working days of receipt of funds, all funds received by a broker or salesperson in connection with the sale, purchase or exchange of a yacht shall be deposited in a trust account and shall remain in the account until the funds are disbursed pursuant to an agreement of the parties to the transaction or controlling statute. Trust account funds shall be held in an account separate from the operating account, and in no event shall funds held in a trust account be co-mingled with funds in the operating or any other account.~~
