**Application Review**

Miguel Magallanes architect exam candidate

## Discussion

David Dial – release from suspended license due to citation

Mr. Dial was not present. The issue was before the board based on the Florida Building Code core course was no longer available to satisfy the penalty imposed in the citation and final order. The board discussed the options of imposing hours from the Florida Building Code advanced course list to satisfy the requirement. The board wanted an explanation for Mr. Dial renewing his license and what, if any, practice he may have done while his license was suspended. The board discussed imposing additional hours to comply with the requirement. After discussion the board made the following motion.

Motion: Mr. Costoya moved that the request be tabled to the next meeting to allow staff an opportunity to contact Mr. Dial.

Second: Ms. Bao-Garciga seconded the motion and it passed unanimously.

Mr. Costoya offered to work with Ms. McEwen to identify Florida Building Code advanced courses that are comparable to the core as a means to satisfy the requirement.

Rule 61G1-17.001(11), Professional Fees and Penalties for Architects. – proposed language (11) In addition to the regular biennial renewal fee, the fee to renew either an active or inactive status license after the deadline for renewal (and the license has become delinquent) shall be \$125.00. There will be a \$125.00 delinquency fee.

Motion: Mr. Costoya moved to approve the proposed language as presented.

Second: Mr. Rodriguez seconded the motion, Mr. Johnson opposed, and the motion passed.

Rule 61G1-17.001(8), Fees – proposed language

(8) Any applicant who takes the professional examination may, upon payment of \$75 to the Department and any fees required by NCARB, and at a mutually convenient time, examine her or his answers or questions, papers, grades and grading key upon such terms and conditions as set forth by the Department of Business and Professional Regulation ~~at the office of the Board~~. All such reviews shall be subject to NCARB ~~national~~ and Department testing security requirements in order to insure the integrity of the examination.

Motion: Ms. Gozdz moved that the board approve the proposed language as presented.

Second: Ms. Fishburne seconded the motion and it passed unanimously.

Rule 61G1-17.002(8), Professional Fees and Penalties for Interior Designers – proposed language

(8) Any applicant who takes the professional examination may, upon payment of \$75.00 to the Department, and at a mutually convenient time, examine his answers or questions, papers, grade and grading key upon such terms and conditions as set forth by the Department of Business and Professional Regulation ~~at the office of the Board~~. All such reviews shall be subject to national and Department testing security requirements in order to insure the integrity of the examination.
