- A motion for waiver was submitted to the board for review by the prosecuting counsel on auctioneer Ronny Lewis Griffith. The case was subsequently pulled from the agenda by the attorney as it was deemed a duplicate case which had been heard and acted on at an earlier date by the board.
- Mr. Dietrich discussed the status of the move to have auctioneer applicants fingerprinted before licensing. He indicated that a bill has been filed and Representative Frank Atkinson will sponsor the bill. By having fingerprints required for auctioneer applicants, this may help detect individuals with criminal backgrounds before they enter the profession.
- The board reviewed its financial statements for the first quarter of the fiscal year and was apprised that the board is in good financial standing. The operating account as of September 30, 2005 has a balance of \$106,447; the recovery fund account has a balance of \$738,259; and the unlicensed activity account has a balance of \$20,817. The board will meet in Tallahassee for its next meeting on March 16, 2006. The members would like to meet with Mr. Marc Drexler to receive a brief on the collections procedures he uses to collect funds into the auctioneers' account when fines have been levied against an auctioneer because of discipline. Mr. Drexler has been notified and will attend the meeting.
- Online auctioning continues to be a topic of discussion for the board. The
 investigations section provided a report of cases it had opened in regards to
 the number of businesses allegedly offering to auction off items without an
 auctioneer's license. Of the thirteen preliminary investigations opened, twelve
 were closed and one is pending review. To provide a more concerted effort by
 the investigative staff, the board was requested to provide any direct
 information to staff regarding their knowledge of any suspected activity so that
 investigations may have more concrete information to work from.
- The board requested the department to put out news releases in the specific area where an auctioneer lives when he or she has been disciplined by the board. The board was advised that this issue would be brought before the department. The board felt this is a viable deterrent to unlicensed activity as well as unethical activity by licensed auctioneers.
