## **CASE LOAD STATUS**

Ms. Leigh's report dated November 27, 2007 reflected five cases in legal, one case set for expert review, five cases set for administrative complaint, one case was set for default, one case was set for settlement negotiations and six cases set for board review. There were a total of thirteen cases in legal.

#### PROSECUTING ATTORNEY REPORT

## #2006-069842, Alan David Loeser

The respondent was not present and was not sworn in via the court reporter. Mr. Loeser's attorney faxed a letter on his behalf requesting his client be granted a continuance until the next meeting.

Motion: Mr. Dietrich moved to deny Mr. Loeser's attorney request for a

continuance until the next meeting based on legal problems in several

other states and the well being of others in the state of Florida.

Second: Mr. Moecker seconded the motion and it passed unanimously.

Ms. Leigh presented case #2006-069842, Alan David Loeser, AU2711. The department filed an administrative complaint against the respondent on July 24, 2007. The administrative complaint charged the respondent with violating Section 468.389, (1) (k) F.S., having a license to practice a comparable profession revoked, suspended, or otherwise acted against by another state, territory, or country. The respondent responded to the election of rights form and decided not to dispute the charges.

Ms. Leigh stated that "the department believed that it is appropriate for the Chair to entertain a motion adopting the allegations and facts and conclusion of law contained in the administrative complaint of those of the board after which the department will request that the board impose penalties within their guidelines."

Motion: Mr. Accardo moved to approve the findings of facts and conclusions of

law.

Second: Mr. Moecker seconded the motion and it passed unanimously.

Ms. Leigh stated that "the department's recommendation in this case is that Alan David Loeser pay a fine of \$1000, costs in the amount of \$139.99 and revoke his license.)

Motion: Mr. Moecker moved to approve the board recommendation. Second: Mr. Accardo seconded the motion and it passed unanimously.

## #2007-012768, Joseph Shaia

Ms. Leigh presented case #2007-012768, AU717. The respondent was not present and was not sworn in via the court reporter. The department filed an administrative complaint against respondent on August 7, 2007. The administrative complaint charged that the respondent with violating Chapter 468.389 (1)(d) F.S., false, deceptive, misleading, or untruthful advertising shall be grounds for the disciplinary activities provided in subsections (2) and (3); Section 468.388 (11)(a) F.S, all advertising by an auctioneer or auction business shall include the name and Florida license number of such auctioneer and auction business. The term "advertising" shall not include articles of clothing, directional signs, or other promotional novelty items; Section 468.389 (1)(j) F.S. Violating a statute or administrative rule regulating practice under this part or a lawful disciplinary order of the board or the department; and Section 468.385 (7)(b) F.S., no business shall auction or offer to auction any property in this state unless it is licensed as an auction business by the board or is exempt from licensure under this act. Each application for licensure shall include the names of the owner and the business, the business mailing address and location, and any other information which the board may require. The owner of an auction business shall report to the board within 30 days of any change in this required information. The respondent has requested through his election of rights form to have an informal hearing not disputing issues and material facts of the administrative complaint pursuant to Rule 28-106.111, F.A.C.

Ms. Leigh stated that "the department believed that it is appropriate for the Chair to entertain a motion adopting the allegations and facts and conclusion of law contained in the administrative complaint of those of the board after which the department will request that the board impose penalties within their guidelines."

Motion: Mr. Shearer moved to approve the findings of facts and conclusions of

law.

Second: Mr. Dietrich seconded the motion and it passed unanimously.

Ms. Leigh stated that "the department's recommendation in this case is that Joseph Shaia, case #2007-012768, AU717, pay a fine in the amount of \$2000, costs of \$146.31 and revoke his license.

Motion: Mr. Dietrich made a motion for Joseph Shaia to pay a \$2000 fine, \$146.31

costs and revoke his license.

The department filed an administrative complaint against respondent on March 7, 2007. The respondent has been charged with violating Section 468.389 (1)(c), F.S.; failure to account for or to pay or return, within a reasonable time not to exceed 30 days, money or property belonging to another which has come into the control of an auctioneer or auction business through an auction shall be grounds for the disciplinary activities provided in sub-section (2) and (3); and Section 468.389 (1)(e), any conduct in connection with a sales transaction which demonstrates bad faith or dishonesty. The respondent failed to file an election of rights form or otherwise establish the disputing issues and material facts of the administrative complaint pursuant to Rule 28-106.111, F.A.C. By failing to request a hearing within 21 days of receipt of agency pleading, the respondent has waived his right to request a hearing where there is a disputed issue of material facts. The department believes that it is appropriate at this time for the chair to entertain a motion finding that the respondent waived his right to a hearing.

Ms. Leigh presented case #2005-058401, AB1380. The respondent was not present and was not sworn in via the court reporter. The department filed an administrative complaint against respondent on March 7, 2007. The respondent has been charged with violating Section 468.389 (1)(c), F.S.; failure to account for or to pay or return, within a reasonable time not to exceed 30 days, money or property belonging to another

which has come into the control of an auctioneer or auction business through an auction shall be grounds for the disciplinary activities provided in sub-section (2) and (3); and Section 468.389 (1)(e), any conduct in connection with a sales transaction which demonstrates bad faith or dishonesty. The respondent failed to file an election of rights form or otherwise establish the disputing issues and material facts of the administrative complaint pursuant to Rule 28-106.111, F.A.C. By failing to request a hearing within 21 days of receipt of agency pleading, the respondent has waived his right to request a hearing where there is a disputed issue of material facts. The respondent has been charged with violating Section 468.389 (1)(c), F.S., failure to account for or to pay or return, within a reasonable time not to exceed 30 days, money or property belonging to another which has come into the control of an auctioneer or auction business through an auction shall be grounds for the disciplinary activities provided in sub-section (2) and (3). The respondent failed to file an election of rights form or otherwise establish the disputing issues and material facts of the administrative complaint pursuant to Rule 28-106.111, F.A.C. By failing to request a hearing within 21 days of receipt of agency pleading, the respondent has waived his right to request a hearing where there is a disputed issue of

The respondent has been charged with violating Section 468.389 (1)(c), F.S., failure to account for or to pay or return, within a reasonable time not to exceed 30 days, money or property belonging to another which has come into the control of an auctioneer or auction business through an auction. The respondent failed to file an election of rights form or otherwise establish the disputing issues and material facts of the administrative complaint pursuant to Rule 28-106.111, F.A.C. By failing to request a hearing within 21 days of receipt of agency pleading, the respondent has waived his right to request a hearing where there is a disputed issue of material facts. The department believes that it is appropriate at this time for the chair to entertain a motion finding that the respondent waived his right to a hearing.

Ms. Cheri Melchione recovery claim against A&E Auctions, AB1122, Case #2002-000601 was approved. The board granted her \$50,000 to be released via the Department by January 15, 2008.

Motion: Mr. Accardo made a motion to pay Ms. Cheri Melchione \$50,000 from the

recovery funds by January 15, 2008.

Second: Mr. Shearer seconded the motion and it passed unanimously.

## State of Michigan

Mr. Spivey presented a letter from the State of Michigan showing interest in a reciprocity agreement with the state of Florida. The State of Michigan is willing to compile the material and provide them to the state of Florida for their investigation.

Motion: Mr. Shearer made a motion for the Department to work with the State of

Michigan on the reciprocity agreement.

Second: Mr. Dietrich seconded the motion and it passed unanimously.
