Second: Mr. Dietrich seconded the motion and it passed unanimously.

APPLICATION REVIEW

Kale E. Albritton - Mr. Albritton was present and was sworn in by the court reporter. Mr. Dietrich informed the board that he had known Mr. Albritton for 40 plus years and he found him to be an honest auctioneer. Mr. Flynn asked Mr. Dietrich would he be able to render a fair decision in this case. Mr. Dietrich stated: "facts is the facts". Mr. Albritton gave a verbal history of why his license was not renewed in a timely manner.

Motion: Mr. Dietrich made a motion to approve his application for reinstatement.

Second: Mr. Accardo seconded the motion and it passed unanimously.

Gary Wayne Bowman - Mr. Bowman was present and was sworn in by the court reporter. Mr. Bowman gave a verbal history of why his license was not renewed in a timely manner.

Motion: Mr. Dietrich made a motion to approve his application for reinstatement.

Second: Mr. Accardo seconded the motion and it passed unanimously.

John W. Coakley - Mr. Coakley was present and was sworn in by the court reporter. Mr. Coakley gave a verbal history of why his license was not renewed in a timely manner. Staff provided Mr. Coakley with a copy of the Florida laws and rules.

Motion: Mr. Dietrich made a motion to approve his application for reinstatement.

Second: Mr. Accardo seconded the motion and it passed unanimously.

Scott Alexander Peterson – Mr. Peterson was not present or represented by council. Mr. Peterson failed to submit unusual illness hardship to allow the board to reinstate his license.

Motion: Mr. Dietrich made a motion to deny his application.

Second: Mr. Shearer seconded the motion and it passed unanimously.

Jake A Shallow – Mr. Shallow was present and was sworn in by the court reporter. Mr. Shallow gave a verbal history of why his license was not renewed in a timely manner.

Motion: Mr. Dietrich made a motion to approve his request for reinstatement.

Second: Mr. Accardo seconded the motion and it passed unanimously.

Jimmy Franklin Tipton – Mr. Tipton was present and was sworn in by the court reporter. He was convicted of mail and/or insurance fraud which affected his ability to practice and his insurance agent license was revoked in the state of Florida. The board members denied his application on June 12, 2009. Mr. Tipton challenged the denial by submitting additional information, requesting a hearing and appearing before the board. The board vacated the denial and granted his application for licensure by examination. He must appear before the board at its December 2010 general meeting and give a full report and account of his practice as an auctioneer.

Motion: Mr. Dietrich made a motion to approve his application for licensure by

examination.

Second: Mr. Shearer seconded the motion and it passed unanimously.

Mr. Tipton thanked Pam and Renese for their outstanding services rendered to him.

PROSECUTING ATTORNEY REPORT

CASE LOAD STATUS

Ms. Parson presented the prosecuting attorney report in a new format that consisted of more details on each case. She agreed to provide the members with a copy of the status codes via e-mail.

#2008-019875, Blen Gibson, AU31

Ms. Parson presented case #2008-019875, Blen Gibson, AU 31. The respondent was present and sworn in by the court reporter. The department filed an administrative complaint against respondent on February 5, 2009. The respondent has been charged with violating Section 468.389 (1)(j), violating a statute or administrative rule regulating the practice under this part or a lawful disciplinary order of the board or the department shall be grounds for the disciplinary activities provided in subsections (2), (3) and 468.388 (4) each auction must be conducted by an auctioneer who has an active license or by an apprentice who has an active apprentice auctioneer license and who has received prior written sponsor consent. Each auction must be conducted under the auspices of a licensed auction business. Any auctioneer or apprentice auctioneer conducting an auction, and any auction business under whose auspices such auction is held, shall be responsible for determining that any auctioneer, apprentice, or auction business with whom they are associated in conducting such auction has an active Florida auctioneer, apprentice, or auction business license.

Based on the new evidence, Ms. Parson requested that the board terminate and dismiss the administrative complaint.

Motion: Mr. Dietrich moved to withdraw the informal hearing motion and terminate

the administrative complaint.

Second: Mr. Shearer seconded the motion and it passed unanimously.

Motion: Mr. Shearer moved to dismiss the administrative complaint.

Second: Mr. Dietrich seconded the motion and it passed unanimously.

Recess

#2008-065058, Joseph Benigo d/b/a Bestbuy Auctioneer, AU 3555

Ms. Parson presented case #2008-065058, AB 3555. The respondent was not present and was not sworn in by the court reporter. The department filed an administrative complaint against the respondent on March 4, 2009. The administrative complaint charged the respondent with violating Chapter 468.389(1)(j) violating a statute or administrative rule regulating practice under this part or a lawful disciplinary order of the board or the department and 468.388 (4) each auction must be conducted by an auctioneer who has an active license or by an apprentice who has an active apprentice auctioneer license and who has received prior written sponsor consent. The board rejected the respondent settlement agreement to pay a fine of \$250.00 and \$183.79 costs.

Motion: Mr. Accardo made a motion for the board to reject the settlement

stipulation as presented by the department.

Second: Mr. Shearer seconded the motion and it passed unanimously.

#2008-038299, Travis W. McCluskey d/b/a Lucky Bidder Auction, AB 2673

Ms. Parson presented case #2008-038299, Travis W. McCluskey d/b/a Lucky Bidder Auction, AB 2673. The respondent was present and sworn in by the court reporter. The department filed an administrative complaint against respondent on March 5, 2009. The respondent has been charged with violating Section 468.389 (1)(j), violating a statute or administrative rule regulating practice under this part or a lawful disciplinary order of the board or the department shall be grounds for the disciplinary actions provided in subsections (2), (3), 468.389 (1) (c) failure to account for or to pay or return, within a reasonable time not to exceed 30 days, money or property belonging to another which has come into the control of an auctioneer or auction business through an auction. The respondent failed to file an Election of Rights form disputing issues of material facts of the administrative complaint pursuant to Rule 28-106.111, F.A.C. By

failing to request a hearing within 21 days of receipt of agency pleading, the respondent has waived the right to request a hearing where there is a disputed issue of material facts. The department believes that it is appropriate at this time for the chair to entertain a motion finding that the respondent waived the right to a hearing.

Motion: Mr. Accardo moved to approve that the respondent waived the right to a

hearing.

Second: Mr. Shearer seconded the motion and it passed unanimously.

Ms. Parson stated that "the department believes that it is appropriate for the chair to entertain a motion adopting the allegations and facts and conclusions of law contained in the administrative complaint of those of the board after which the department will request that the board impose penalties within their guidelines."

Motion: Mr. Accardo moved to approve the findings of facts and conclusions of

law.

Second: Mr. Shearer seconded the motion and it passed unanimously.

Ms. Parson stated that "the department's recommendation in this case is that Travis W. McCluskey d/b/a Lucky Bidder Auctions, AB 2673, pay a fine in the amount of \$2000, costs of \$692 and revoke the license.

Motion: Mr. Shearer made a motion for Travis W. McCluskey d/b/a Lucky Bidder

Auctions to pay a \$2000 fine, \$692 costs and revoke this license.

Second: Mr. Dietrich seconded the motion and it passed unanimously.

#2008-032429, Abraham Avi Asher, AU1623

Mr. Asher requested a continuance to the next meeting.

Motion: Mr. Dietrich moved to deny Mr. Asher's request.

Second: Mr. Shearer seconded the motion and it passed unanimously.

Ms. Parson presented case #2008-032429, Abraham Asher, AU 1623. The respondent was not present or represented by council. The department filed an administrative complaint against respondent on June 22, 2009. The respondent has been charged with violating Section 468.389 (1)(j), 468.388 (4) each auction must be conducted by an auctioneer who has an active license or by an apprentice who has an active apprentice auctioneer license and who has received prior written sponsor consent. Each auction must be conducted under the auspices of a licensed auction business. Any auctioneer or apprentice auctioneer conducting an auction, and any auction business under whose auspices such auction is held, shall be responsible for determining that any auctioneer,

apprentice, or auction business with whom they are associated in conducting such auction has an active Florida auctioneer, apprentice, or auction business license. The respondent failed to file an Election of Rights form or otherwise establish the disputing issues and material facts of the administrative complaint pursuant to Rule 28-106.111, F.A.C. By failing to request a hearing within 21 days of receipt of agency pleading, the respondent has waived the right to request a hearing where there is a disputed issue of material facts. The department believes that it is appropriate at this time for the chair to entertain a motion finding that the respondent waived the right to a hearing.

Motion: Mr. Shearer moved to approve that the respondent waived the right to a

hearing.

Second: Mr. Accardo seconded the motion and it passed unanimously.

Ms. Parson stated that "the department believes that it is appropriate for the Chair to entertain a motion adopting the allegations and facts and conclusions of law contained in the administrative complaint of those of the board after which the department will request that the board impose penalties within their guidelines."

Motion: Mr. Shearer moved to approve the findings of facts and conclusions of

aw.

Second: Mr. Moecker seconded the motion and it passed unanimously.

Mr. Flynn requested Ms. Parson to read Mr. Asher statement into the record:

- 1. "Ezra Abadi is my uncle and has been an auctioneer for the last 40 or 50 years. He came with me to the auction as he had just completed surgery and I thought that a trip would help him.
- 2. At the time that this occurred I had no ideal that Ezra Abadi was not licensed in Florida as I have always known him to be an auctioneer. Ezra Abadi did appear before the board after this occurrence on an unrelated matter and according to the issue was resolved.
- 3. I am currently licensed in 7 states and my and my record is spotless in all states. I have been licensed in Florida since 1994. I have never had a complaint in any state other than Florida and both times the complaints were for omitting to include my license number in an advertisement. I accepted full responsibility for the two occurrences even though the advertisement were placed by a third party. I have been auctioning nearly weekly throughout the USA since 1979 without any complaints against me in any state, whether a state license is required or not. I am a full time auctioneer and my license is 100% derived from auctioneering.
- 4. I realize that a rule was broken when Ezra Abadi started auctioning but please consider that he only auctioned about 3 or 4 items and I was by his side the entire time.

I respectfully ask that you consider the circumstances and impose the minimum fine, if any.

Ms. Parson stated that "the department's recommendation in this case is that Abraham Asher. AU 1623, pay a fine in the amount of \$1000, costs of \$120.47 and revoke the license.

Motion: Mr. Accardo made a motion for Abraham Asher to pay a \$1000 fine,

\$120.47 costs and revoke the license.

Second: Mr. Dietrich seconded the motion and it passed unanimously.

Motion: Mr. Dietrich made a motion requesting board staff to send a written

response to Kimberly Routt's supervisor. The board members were impressed with the investigated report she completed on Mr. Asher case.

Second: Mr. Accardo seconded the motion and it passed unanimously.

BOARD COUNSEL REPORT

Mr. Flynn informed the board that he withdrew the 2007 null and void rule. At the next meeting he will be submitting new language in a draft format for the board to review and vote on the language.

Mr. Moecker requested Mr. Flynn to provide the members with the language prior to the release of the March 12, 2010 agenda.

Mr. Flynn will be working with Mr. Spivey and Ms. Parson on updating all of the rules. He has requested Mr. Spivey and Ms. Parson to submit the rules they see that need to be worked on. Mr. Dietrich will also be working with Mr. Flynn.

BOARD CHAIR REPORT

Mr. Moecker requested staff to provide the board with the number of recovery applications received, the amount of each claim and the amount paid out of the recovery funds. Mr. Moecker has not gone back to Senator Baker who agrees to sponsor the fingerprint bill. He thinks the best way to show him is to gather the costs paid out of the recovery funds for the past 10 plus years. Mr. Moecker stated "until the board can prove to the Governor there is a need to go forward with the bill."

The board is requesting the department to authorize out of state travel for two individuals to attend the National Auctioneers Convention to be held June 14-17, 2010 in Greensboro, North Carolina. Mr. Spivey reminded them of the restriction on out of state travel.

The board has requested the Division of Regulation to provide a briefing regarding the investigation process of auctioneer cases.

Mr. Dietrich stated that the next Florida Auctioneers Association (FFA) meeting will be held in Lake Mary, Florida, June 13-15, 2010 in the Orlando area. The board members agreed to have their regular board meeting on Monday, June 14, 2010.

EXECUTIVE DIRECTOR'S REPORT

Mr. Spivey informed the board that Secretary Drago is no longer the secretary. He is presently employed by the governor's office. Deputy Secretary Charlie Liem is currently the Interim Secretary.

Mr. Spivey informed the members that the department is requesting every licensee to report their criminal history to the department within 30 days. The department has developed a criminal self-reporting form and it is located on the Internet.

Mr. Spivey reviewed the financial reports ending June 30, 2009. He indicated that the "operating account shows a balance of \$63,678. The operating account for the recovery fund shows a balance of \$483,272 and the unlicensed activity account shows a balance of \$30,954."
