The meeting was opened with a roll call and a quorum was established.

APPROVAL OF MINUTES

Mr. Bill Gilbert moved to accept the minutes from the April 2, 2013, Board meeting. Mr. Edwin Stewart seconded the motion and the motion passed unanimously.

DISCIPLINARY MATTERS

Informal Hearing

Ms. Elizabeth Henderson, Assistant General Counsel, presented the following cases for consideration by the Board. The Board found that the Respondent was properly served with the Administrative Complaint, that there was competent and substantial evidence to support the allegations as set forth in the Administrative Complaint and adopts them as the findings of fact and conclusions of the law of the Board and imposed the penalties shown below:

Michael Jones; Orlando; Case No. 2011.054244

Mr. Jones was present for the meeting and was sworn in by Ms. Blythe Riggs, Court Reporter. Vice Chair Tommy Vaughn moved that the Board impose a fine of \$500 and costs of \$158.32, to be paid over a period of six months, with the first payment of \$158.32 due within 30 days of the final order and five monthly payments of \$100 each, plus six months stayed suspension against barber license BB23783. In the event the Respondent fails to comply with the terms of the final order, the stay shall be lifted and the barber license will be suspended. Mr. Gilbert seconded the motion and the motion passed unanimously.

Headquarter South Corp.; Cutler Bay; Case Nos. 2011.060079 and 2011.060140

The Respondent was not present for the meeting. Vice Chair Vaughn moved that the Board impose a fine of \$1,000 and costs of \$128.28, to be paid over a period of six months, with the first payment of \$128.28 due within 30 days of the final order and five monthly payments of \$200 each, plus six months stayed suspension against barbershop license BS1079564. In the event the Respondent fails to comply with the terms of the final order, the stay shall be lifted and the barbershop license will be suspended. Mr. Andrew Raines seconded the motion and the motion passed unanimously.

Razor Cutz; Orlando; Case Nos. 2011.060198 and 2012.002968

Mr. Joseph Jackson was present for the meeting and was sworn in by the Court Reporter. Mr. Gilbert moved that the Board impose a fine of \$500 and costs of \$125.74, to be paid over a period of six months, with the first payment of \$125.74 due within 30 days of the final order and five monthly payments of \$100 each, plus six months stayed suspension against barbershop license BS1079366. In the event the Respondent fails to comply with the terms of the final order, the stay shall be lifted and the barbershop license will be suspended. Vice Chair Vaughn seconded the motion and the motion passed unanimously.

Joseph Harris; Orlando; Case No. 2012.008215

Mr. Harris was present for the meeting and was sworn in by the Court Reporter. The Board referred the case to the Division of Administrative Hearings for a formal hearing.

Motion for Waiver of Rights and Final Order

Ms. Henderson presented the following cases for consideration by the Board. The Board found that the Respondent was properly served with the Administrative Complaint, that there was competent and substantial evidence to support the allegations as set forth in the Administrative Complaint and adopts them as the findings of fact and conclusions of the law of the Board and imposed the penalties shown below:

April Michelle Thomas; Sarasota; Case No. 2011.023579

Ms. Thomas was not present for the meeting. Vice Chair Vaughn moved that the Board impose a fine of \$1,500 and costs of \$141.56. Mr. Gilbert seconded the motion and the motion passed unanimously.

Ground Zero Barbershop, Inc.; Orlando; Case No. 2011.045261

The Respondent was not present for the meeting. Vice Chair Vaughn moved that the Board impose a fine of \$500 and costs of \$84.20. Mr. Gilbert seconded the motion and the motion passed unanimously.

Redmon & Dallas and Dallas B. Redmon; Perry; Case Nos. 2012.002077 and 2011.059788

The Respondents were not present for the meeting. Vice Chair Vaughn moved that the Board impose a fine of \$1,500 and costs of \$859.77, to be paid over a period of six months, with the first payment of \$859.77 due within 30 days of the final order and five monthly payments of \$300 each, plus revocation of barbershop license BS12853 and barber license BB28987. Mr. Gilbert seconded the motion and the motion passed unanimously.

Miami Fades Barber Shop Inc.; Miami; Case No. 2011.052131

The Respondent was not present for the meeting. Mr. Gilbert moved that the Board impose a fine of \$1,500 and costs of \$134.93, to be paid over a period of six months, with the first payment of \$134.93 due within 30 days of the final order and five monthly payments of \$300 each, plus six months stayed suspension against barbershop license BS1078248. In the event the Respondent fails to comply with the terms of the final order, the stay shall be lifted and the barbershop license will be suspended. Mr. Raines seconded the motion and the motion passed unanimously.

Amigos Barbershop Inc. and Wilson M. Brioso and Rancisco Manzueta; Orlando; Case Nos. 2011.054707, 2012.009014 and 2012.009009

The Respondents were not present for the meeting. Vice Chair Vaughn moved that the Board impose a fine of \$900 and costs of \$516.48, to be paid over a period of six months, with the first payment of \$516.48 due within 30 days of the final order and five monthly payments of \$180 each, plus six months stayed suspension against barbershop license BS1078462, barber license BB8891306 and barber license BB91662. In the event the Respondent fails to comply with the terms of the final order, the stay shall be lifted and the barbershop license and barber licenses will be suspended. Mr. Gilbert seconded the motion and the motion passed unanimously.

Stephen A. Lancaster; Ft. Pierce; Case No. 2011.051079

Mr. Lancaster was not present for the meeting. Vice Chair Vaughn moved that the Board impose a fine of \$500 and costs of \$66.25, to be paid over a period of six months, with the first payment of \$66.25 due within 30 days of the final order and five monthly payments of \$100 each, plus six months stayed suspension against barber license BB8891660. In the event the Respondent fails to comply with the terms of the final order, the stay shall be lifted and the barber license will be suspended. Mr. Raines seconded the motion and the motion passed unanimously.

Mr. Raines moved that the Board adopt the Stipulation of the parties as the Board's final action in this matter and incorporate it and all of its terms into a final order and impose a fine of \$500 and costs of \$81.08, to be paid over a period of six months, with the first payment of \$81.08 due within 30 days of the final order and five monthly payments of \$100 each, plus six months stayed suspension against barbershop license BB9976767. In the event the Respondent fails to comply with the terms of the final order, the stay shall be lifted and the barbershop license will be suspended. Mr. Gilbert seconded the motion and the motion passed unanimously.

Jean Mendez; Loxahatchee; Case No. 2012.009313

Mr. Mendez was not present for the meeting.
