The meeting opened with a roll call and a quorum was established. The Board excused the absence of Mr. Gilbert and Ms. Munchalfen from the meeting.

DISCUSSION OF STATEMENT OF ESTIMATED REGULATORY COST

A. Rule 61G3-16.006, Florida Administrative Code – Restricted Barber License

Mr. Frizzell provided an explanation for the purpose of the meeting, the procedural history of the process thus far and the expectations of the Board today. He also advised that the members of the public that were present would be afforded an opportunity to comment.

Mr. Frizzell asked Ms. Woodard if the Department had made a determination of whether or not a Statement of Estimated Regulatory Cost (SERC) would be required for this rule.

Ms. Woodard advised that the Department determined that a SERC was not necessary and that the SERC checklist was included in the agenda materials.

At this time, the board opened the floor for public comment. The members of the public who gave comment were sworn in by the court reporter.

After public comment, Mr. Rodriguez made a motion to reconsider the vote taken in April 2019 to reduce the educational hours for restricted barbers from 1200 to 500. Ms. Wold seconded the motion. Ms. Smith and Mr. Nibaldi opposed. The motion failed.

Mr. Frizzell stated due to the board's decision to amend Rule 61G3-16.006, FAC, he is statutorily required to ask the following questions and he would need the answers in the form of a motion and a vote.

1. *Will the proposed rule amounts have an adverse impact on small business?*

Ms. Smith made a motion that the proposed rule amounts would not have an adverse impact on small businesses. Mr. Rodriguez seconded the motion and it passed unanimously.

2. *Will the proposed rule amendment be likely to directly or indirectly increase regulatory costs to any entity, including government, in excess of \$200,000 in the aggregate in Florida within one year after implementation?*

Mr. Nibaldi made a motion that the amendment would not directly or indirectly increase regulatory costs to any entity in excess of \$200,000 in the aggregate in Florida within one year after implementation. Mr. Rodriguez seconded the motion and it passed unanimously.

3. *Should a violation of this rule or any part of this rule be designated a minor violation?*

Mr. Rodriguez made a motion that a violation of this rule or any part would not be designated as a minor violation. Mr. Nibaldi seconded the motion and it passed unanimously.

There being no further business, the meeting adjourned at approximately 11:03 a.m.
