The meeting was opened with a roll call and a quorum was established. Chair White excused Mr. Edwin Stewart's absence from the meeting.

Mr. Andrew Raines moved to accept the minutes from the May 16, 2011, board meeting. Vice Chair Thomas Vaughn seconded the motion and the motion passed unanimously.

DISCIPLINARY MATTERS

Informal Hearings

Ms. Kathleen Brown-Blake, Assistant General Counsel, presented the following cases for consideration by the board. The board found that the Respondent was properly served with the Administrative Complaint, that there was competent and substantial evidence to support the allegations as set forth in the Administrative Complaint and adopts them as the findings of fact and conclusions of the law of the board and imposed the penalties shown below:

809 Barber Shop; Ocoee; Case No. 2010.058868

The Respondent was not present for the meeting. Ms. Julie Rivera moved that the board impose a fine of \$100 and costs of \$221.71. Vice Chair Vaughn seconded the motion and the motion passed unanimously.

A-Class Cuts and Lounge; Orlando; Case Nos. 2010.17376 and 2010.047387

The Respondent was not present for the meeting. Ms. Rivera moved that the board impose a fine of \$1,000 and costs of \$334.56, to be paid over a period of six months, with the first payment of \$334.56 due within 30 days of the final order and five monthly payments of \$200 each. Vice Chair Vaughn seconded the motion and the motion passed unanimously.

Vivaldi Alsindor; Orlando; Case No. 2010.045215

Mr. Alsindor was not present for the meeting. Ms. Rivera moved that the board impose a fine of \$1,000 and costs of \$236.16, to be paid over a period of six months, with the first payment of \$236.16 due within 30 days of the final order and five monthly payments of \$200 each. Vice Chair Vaughn seconded the motion and the motion passed unanimously.

Jeffrey Allen; Tallahassee; Case No. 2010.045207

Mr. Allen was not present for the meeting. Ms. Rivera moved that the board impose a fine of \$1,000 and costs of \$153.03, to be paid over a period of six months, with the first payment of \$153.03 due within 30 days of the final order and five payments of \$200 each. Mr. Raines seconded the motion and the motion passed unanimously.

American Barber & Spa Corp.; Case No. 2010.054381

The Respondent was not present for the meeting. Ms. Rivera moved that the board impose a fine of \$550 and costs of \$40.71, to be paid over a period of six months, with the first payment

of \$40.71 due within 30 days of the final order and five payments of \$110 each. Mr. Raines seconded the motion and the motion passed unanimously.

Earnest Butler III; Tallahassee; Case No. 2010.043034
