The meeting was opened with a roll call and a quorum was established.

DISCIPLINARY MATTERS

Informal Hearing

Ms. Erica White, Assistant General Counsel, presented the following cases for consideration by the Board. The Board found that the Respondents were properly served with the Administrative Complaint, that there was competent and substantial evidence to support the allegations as set forth in the Administrative Complaint and adopts them as the findings of fact and conclusions of the law of the Board and imposed the penalties shown below:

Reinado Miguel Bossio; Orlando; Case No. 2012.007189

The Respondent was present for the meeting and was sworn in by Ms. Beth Masters, Court Reporter. Mr. Edwin Stewart moved that the Board impose a fine of \$1,000 and costs of \$120.12, to be paid over a period of six months, with the first payment of \$120.12 due within 30 days of the final order and five monthly payments of \$200 each, plus revocation of barber license BB8895003.
