- The board approved the following rule language and agreed that there was no small business impact with these changes:

  - Rule 61G3-16.005, Florida Administrative Code – Endorsement
  - Rule 61G3-16.007, Florida Administrative Code – Examination for Restricted Licensure
  - Rule 61G3-16.008, Florida Administrative Code – Manner of Application
  - Rule 61G3-16.0010, Florida Administrative Code – Examination for Barber Licensure
  - Rule 61G3-16.010, Florida Administrative Code – Supervised Practice Exception
  - Rule 61G3-20.002, Florida Administrative Code – Application Fee for Licensure Through Examination or Endorsement and Reexamination Fees
  - Rule 61G3-20.0075, Florida Administrative Code – Examination Review FeeThese rule changes address the repeal of the barber and restricted barber practical examinations.
- The board approved the amendment to Rule 61G3-19.015, Florida Administrative Code – Inspections, which allows for biennial inspections rather than annual inspections. The board agreed that this change did not impact small business.
