## **CALL TO ORDER**

## REVIEW AND APPROVAL OF BOARD MEETING MINUTE

Mr. Sibley made a motion to approve the May 13, 2022 minutes as amended. Vice Chair Pyott seconded the motion. The motion passed unanimously.

Mr. Sibley made a motion to approve the July 26, 2022 minutes as written. Vice Chair Pyott seconded the motion. The motion passed unanimously.

#### **REPORTS**

## PROSECUTING ATTORNEY REPORT – Jerry Hosey

Mr. Hosey provided the Council with a copy of the Office of General Counsel case report. The Council asked if Mr. Hosey would be providing more detailed reports. Mr. Hosey indicated that he would research the matter and provide information as it is available.

## **COUNSEL REPORT – Tom Jones**

The Council was provided with the August 2022 Rules Report. Mr. Jones indicated to the Council that there is one rule, Rule 61E14-3.001, Florida Administrative Code, progressing through the rulemaking process.

## Rule 64E14-4.002, .003, and .005, F.A.C.

The Council reviewed and discussed the above mentioned rules. After discussion, Mr. Sibley made a motion to approve the changes in Rule 61E14-4.002, 003, and .005, Florida Administrative Code. Vice Chair Pyott seconded the motion. The motion passed unanimously.

The Council addressed the Statement of Estimated Regulatory Costs of these rules (SERC). The Council determined that these rule amendments would not have an adverse impact on

small business nor will it be likely to directly or indirectly increase regulatory costs to any entity (including government) in excess of \$200,000 in the aggregate in Florida within one year after the implementation of the rule amendments; should a violation of this rule, or any part of this rule, be designated a minor violation; and should the "Sunset Language" be included in these rules shall be reviewed, and if necessary, repealed, modified, or renewed through the rulemaking process five years from the effective date. All members agreed that no SERC was necessary for the development of the proposed rule amendments. Mr. Sibley made a motion to approve these rule amendments. Vice Chair Pyott seconded the motion. The motion passed unanimously.

# EXECUTIVE DIRECTOR REPORT – Krista Woodard Financial Report – March 31, 2022

Ms. Woodard reported that as of March 31, 2022 the balance in the Council's operating account is \$358,622 and unlicensed activity account is \$290,384.
