REVIEW OF MINUTES

Final Action – January, 2006

The Board voted unanimously to approve these minutes.

EXECUTIVE DIRECTOR'S REPORT

Mr. Vaccaro reported that as of February 2006, there were 5,783 new complaints received. Of these, 3,266 licensed complaints were found legally sufficient and 1,351 unlicensed complaints were found legally sufficient. There were 2,510 Investigations assigned, 1,884 investigations completed, 1,212 mediations assigned and 692 mediations completed. There were also 33 notices of non-compliance issued and 251 citations filed.

CHAIRMAN'S REPORT

Ms. Brown the members to vote to excuse the absences of Mr. Engelmeier, Mr. Thornton and Ms. Watts (General Session only).

Ms. Brown also asked Bruce Kershner to give the board an update on former member Michael Blankenship's health condition. Mr. Kershner reported that Mr. Blankenship is doing well and waiting on the telephone call from the Mayo Clinic.

PROSECUTING ATTORNEY'S REPORT

Mr. Creehan gave the following report:

As of January there were 500 cases in Legal (to be reviewed), there were 215 cases set for probable cause, 160 cases has Probable Cause found/Administrative Complaints filed and 56 cases were ready for default. There were 33 cases with Stipulations executed/Informal Hearing requested, 111 cases that had requested Formal Hearings, 12 cases were referred to DOAH, 70 cases were awaiting Final Orders and 9 cases were trying to reach Settlement Negotiations. There were also 3 cases that were re-opened and 3 cases set for Board Presentation. For the month of January 2006, 85 cases were closed.

The Board also voted unanimously to approve the list of Local Disciplinary Orders.

ATTORNEY GENERAL'S REPORT

A. Phillip Black – Informal Hearing

Mr. Black was present.

Ms. Guillemette presented this case stating that Mr. Black's application for Certification of Registered Contractor's license was denied at the September meeting of the Board.

The basis for the denial was failure to provide the following: Submit proof of written examination Letter of good standing Provide credit reports Proof of filing corporation or fictitious name Completed initial Qualified Business Application Certificate of Competency

Mr. Black timely filed a petition for review of Notice of Intent to Deny.

After discussion, the board voted unanimously to approve Mr. Black's application.

B. Walter Brailly – Informal Hearing

Mr. Brailly was present.

Ms. Guillemette presented this case stating that Mr. Brailly's application to qualify an additional business was denied at the September meeting of the Board.

The denial was based on failure of the applicant to provide proof that he would properly supervise the company as required by Section 489.1195, F.S.

Mr. Brailly filed a petition for review of the Notice of Intent to Deny.

After discussion, the Board voted unanimously to send Mr. Brailly's application to the March 2006 Additional Business Committee.

C. Dale Derby – Informal Hearing

Mr. Derby was present with Attorney Sheryl L. Dobek.

Ms. Guillemette presented this case stating that Mr. Derby's application for change of status was denied at the October meeting of the Board.

The denial was based on an open complaint and unpaid \$100 citation. Since that time the citation has been paid and the complaint has been resolved.

The Notice of Intent to Deny was received on either the 3rd or 5th of December.

Ms. Guillemette asked the Board to consider whether Mr. Derby's Petition was timely.

After discussion, the Board voted unanimously to find Mr. Derby's Petition untimely.

D. Fabricio E. Emmanuelli – Informal Hearing

Mr. Emmanuelli was present.

Ms. Guillemette presented this case stating that Mr. Emmanuelli's application for initial Certified General Contractor was denied at the July meeting of the Board.

The denial was based on the applicant's failure to provide proof of the Restoration of his Civil Rights.

After discussion, the Board voted unanimously to set aside the Notice of Intent to Deny and refer this application to the March 2006 Application Review Committee.

E. Charles Hodges – Informal Hearing

Mr. Hodges was present.

Ms. Guillemette presented this case stating that Mr. Hodges application for Certification of Registered License was denied at the September meeting of the Board.

The denial was based on the applicant's failure to submit the following: Current certificated of competency Credit reports, bank verification letter and financial statements

Mr. Hodges timely filed a petition for review of Notice of Intent to Deny.

Mr. Hodges provided the missing items.

After discussion, the Board voted unanimously to approve Mr. Hodges application.

F. Sherif Kodsy – Informal Hearing

Neither Mr. Kodsy nor his Attorney was present.

Ms. Guillemette presented this case stating that Mr. Kodsy had requested a continuance. Ms. Guillemette also stated that Mr. Kodsy's application for initial Registered Building Contractor was denied at the September meeting of the Board.

The denial was based on the applicant's failure to provide proof of Restoration of Civil Rights.

After discussion, the board voted to set aside the Notice of Intent to Deny and send Mr. Kodsy's application to the March 2006 Application Review Committee.

G. Shawna Mitchell – Informal Hearing

Ms. Mitchell was present.

Ms. Guillemette presented this case stating that Ms. Mitchell's application to qualify an additional business was denied at the September meeting of the Board.

The denial was based on the applicant's failure to appear.

After discussion, the Board voted unanimously to send this application back to the March 2006 Additional Business Committee.

H. Southeastern Building Trades Association – Informal Hearing

Nancy Winters was present.

Ms. Guillemette presented this case stating that the application for approval of SBTA's Continuing Education Courses was denied at the September meeting of the Board.

The denial was based on failure to provide proof that the courses were interactive.

SBTA timely filed a petition for review of Notice of Intent to Deny. The petition included attachments detailing the course, tracking methods, and interactivity ability.

After discussion, the Board voted unanimously to uphold the denial of the applications.

University of Florida – Informal Hearing

Dr. Ralph Ellis and John C. Norton were present.

Ms. Guillemette presented this case stating that the University of Florida's application for approval of Continuing Education was denied at the September meeting of the Board.

The denial was based on the failure of the applicant's to provide an outline with enough specificity for the Board to consider the course.

A timely request was filed.

After discussion, the Board voted unanimously to approved the application.

J. Juanita Hayes – Request for Reinstatement of Null and Void License

Ms. Hayes was present.

Ms. Guillemette presented this case stating that this is a request to reinstate her General Contractor's license as provided in 455.271(6)(b), F.S.

Ms. Hayes stated that her license was in good standing for twenty years without any complaints. Ms. Hayes also stated that she was injured at work which resulted in five operations. She also had complications from surgery that led to her going into a coma and almost dying.

Ms. Hayes expenses were covered by workers' comp. The adjuster was to pay the renewal and told Ms. Hayes it was taken care of.

After discussion, the Board voted unanimously to approve this petition.

K. Jack Morgan – Request for Reinstatement of Stay of Suspension

Mr. Morgan was present.

Ms. Guillemette presented this case stating that Mr. Morgan's contractor's license was suspended as a result of a third unsatisfactory probation appearance at the April 2005 Probation committee hearing.

Mr. Morgan's September 2005 letter explains why that information was not available to him in April and requests that the Board reinstate the stay of suspension and allow him to continue on probation.

Mr. Morgan's request came before the Board in October. Mr. Morgan was not present and his request for reinstatement of stay was denied.

At the January 2006 meeting, Mr. Morgan presented a letter of October 7, 2005, and a letter dated October 28, 2005, explaining his absence from the October meeting and requested that the Board reconsider his request for reinstatement of stay. Mr. Morgan was not present at this meeting and his request for reinstatement of stay was denied.

Mr. Morgan now presents a letter dated January 17, 2006, advising that he did not receive notice of the meeting held in January 2006. The Board Office has provided confirmation from the United States Postal Service that delivery was attempted and that the notice remains unclaimed.

After discussion, the Board voted unanimously to uphold their previous decision and not reinstate the stay of suspension.

L. Randall W. Regas – Request for Reinstatement of Null and Void License

Mr. Regas was present.

Ms. Guillemette presented this case stating that Mr. Regas is requesting to reinstate his Null and Void Certified Building Contractor's license as provided in 455.271(6)(b), F.S.

Mr. Regas' petition explained several unfortunate circumstances, however, after discussion, the Board voted unanimously to deny this petition.

M. David Van Wormer – Request for Reinstatement of Null and Void License

Mr. Van Wormer was present.

Ms. Guillemette presented this case stating that Mr. Van Wormer is requesting to reinstate his Null and Void Mechanical Contractor's license as provided in 455.271(6)(b), F.S.

Mr. Van Wormer's petition explained several unfortunate circumstances, however, after discussion, the Board voted unanimously to deny Mr. Van Wormer's request.

N. Daniel Winkler – Request for Reinstatement of Null and Void License

Mr. Winkler was present with Attorney Stewart Capps.

Ms. Guillemette presented this case stating that Mr. Winkler is requesting to reinstate his Null and Void General Contractor's license as provided in 455.271(6)(b), F.S.

Mr. Winkler's petition explained some unfortunate circumstances, however, after discussion, the Board voted unanimously to deny Mr. Winkler's request.

O. Mark Pietanza – Petition for Declaratory Statement

Mr. Pentanza was present.

Ms. Guillemette presented this case stating that Mr. Pietanza has requested a Declaratory Statement, which was filed with the Department on December 2, 2005. It was notice in the Florida Administrative Weekly on December 30, 2005. The petition requests clarification to the following question:

1. Does Chapter 489, F.S., require that a state-licensed sheet metal contractor subcontract the installation of a steel roof curb when the sheet metal contractor installs a hood exhaust system?

After discussion, the Board voted unanimously to find that the Declaratory Statement was sufficient to meet Statutory and Rule requirements and to answer this question in the negative.
