### **Major Issues/Actions**

- The board conducted a rule hearing workshop on September 12, 2007 for Rules 61G4-15.006, 61G4-15.005, and 61G4-12.011, Florida Administrative Code. These rules encompass the financial responsibility requirements for contractor applicants. Testimony was received from contractor associations, application services, and the Florida Surety Association.
- The ad hoc committee on licensure requirements met and considered requiring W-2 forms as proof of experience for construction applications. In addition, the committee decided to review experience requirements for electrical contractors, develop a definition for "supervision" as it relates to experience qualifications, and review the use of "journeyman status" as an experience requirement.

# Legislation/Rule Promulgation

- The board decided to revise the proposed financial responsibility rule to allow an irrevocable letter of credit in lieu of a bond. In addition, all applicants would be required to provide proof of satisfaction of unpaid liens and judgments.
- The Joint Administrative Procedures Committee, through Ms. Marjorie Holladay, has indicated a number of issues with proposed Rule 61G4-15.033, Florida Administrative Code, establishing a marine specialty contractor category. The board authorized Dan Biggins, Board Counsel, to respond to Ms. Holladay's concerns.

## **Action Required**

- Mr. Biggins will make the proposed changes to the financial responsibility rule and respond to Ms. Holladay's concerns regarding the marine specialty contractor rule.
- CILB staff will prepare information regarding the experience requirements for electrical contractors and the use of W-2 forms for the October, 2007 meeting.
