EXECUTIVE DIRECTOR'S REPORT – G.W. HARRELL

Mr. Harrell thanked the board for their work during Final Action the previous day and proposed the idea of allotting a lunch break in the middle of Final Action, and possibly scheduling more committee meetings on Wednesday or Friday to ease the load Thursday. Mr. Harrell also stated he would make sure that local discipline cases are checked by OGC to make sure they're compliant with local discipline before they appear in front of the board. Mr. Harrell also mentioned that the department has proposed the idea of eliminating the Qualified Business License.

With no further discussion the board voted unanimously to approve this report.

PROSECUTING ATTORNEY'S REPORT – JEFF KELLY

Mr. Kelly gave the following report:

For the month of January 2009, the overall case load was 1,952, up from 1,893 for December 2008 and down from 2,052 in January of 2008.

There were 549 cases to be reviewed in Legal, 129 cases set for Probable Cause and 436 cases where probable cause had been found/administrative complaints filed. 134 cases were ready for default, 33 cases had stipulations executed/informal hearings requested, and 120 had requested formal hearings. There were 27 cases referred to DOAH, 91 cases in settlement negotiations, 224 cases awaiting final orders, and 209 cases set for board presentation. There were 0 cases under appeal and 0 cases reopened. 186 cases were closed for the month of January.

ATTORNEY GENERAL'S REPORT – DAN BIGGINS

LANCELOT BRYAN - REQUEST FOR INFORMAL HEARING

Mr. Biggins presented this case stating Matthew Distelhurst's application for initial issuance of a Certified General's Contractor's license was denied for failure to demonstrate the required experience and prior discipline issues. Mr. Distelhurst received a Notice of Intent to Deny. Mr. Distelhurst timely requested board reconsideration.

After discussion the board voted unanimously to approve the application as a Certified Building Contractor.

GEORGE GUZMAN - REQUEST FOR INFORMAL HEARING

Mr. Guzman was present.

Mr. Biggins presented this case stating George Guzman's application for initial issuance of a Certified General Contractors license was denied for failure to demonstrate the required experience and failure to demonstrate financial stability. Mr. Guzman received a Notice of Intent to Deny. Mr. Guzman timely requested board reconsideration.

After discussion the board voted unanimously to uphold the denial.

CLINTON HENNECY – PETITION FOR VARIANCE AND WAIVER

Mr. Hennecy was present with Counsel, Tim Atkinson.

Mr. Biggins presented this case as a petition for variance of waiver of rule 61G4-15.001 (2). Mr. Harrell stated Mr. Hennecy has passed the General Contractors Examination and would like to use that exam to be issued a Certified Specialty License for the construction of communication towers.

After discussion the board voted unanimously to grant the petition for variance and waiver.

ELLIOT JAMES JENKINS - REQUEST FOR INFORMAL HEARING

Mr. Jenkins was present.

Mr. Biggins presented this case stating Elliot Jenkin's application for initial licensure for a Certified General Contractors license was denied for failure to demonstrate the required experience and for pending discipline. Mr. Jenkins received a Notice of Intent to Deny. Mr. Jenkins timely requested board reconsideration.

After discussion the board voted unanimously to approve the application as a Certified Building Contractor.

CHARLES MILLER - REQUEST FOR INFORMAL HEARING

Mr. Miller was present with Counsel.

Mr. Biggins presented this case stating Charles Miller's application for initial licensure as a Certified Class B Air Conditioning contractor was denied for failure to demonstrate the required experience, failure to show good moral character, and having been found guilty of crimes related to the practice of contracting, and issues with the experience verifier. Mr. Miller received a Notice of Intent to Deny. Mr. Miller timely requested board reconsideration. Mr. Miller requested a 60 day continuance.

After discussion the board voted unanimously to grant a 60 day continuance.

ROBERT RAINES - RECOMMENDED ORDER

Mr. Biggins presented this case as a Recommended Order on a ruling from an Administrative Law Judge. Mr. Biggins stated the Administrative Law Judge upheld the Board's decision to deny the application and found Mr. Raines ineligible to obtain licensure.
