CHAIRMAN'S REPORT

Mr. Del Vecchio asked the board members to vote to excuse the absences of Thomas Thornton and Lee-En Chung.

PROSECUTING ATTORNEY'S REPORT

Mr. Creehan gave the following report:

As of July 2006, there were 311 cases in Legal, 59 of these cases were set for probable cause, 136 cases had probable cause found/administrative complaints filed, 47 cases were ready for default and 74 cases had stipulations executed/informal hearing requested. There were also 89 cases with formal hearings requested, 7 cases were referred to DOAH, 29 cases were awaiting final orders and 9 cases were in settlement negotiations.

ATTORNEY GENERAL'S REPORT

YANUARIO ARIAS

Mr. Arias was not present.

Ms. Guillemette presented this case stating the Mr. Arias' application for a change of status from one business to another was approved with the condition of 2 years probation at the May 2006 Board meeting. Mr. Arias' timely filed a 'Petition to Appeal' the "Intent to approve with conditions".

Mr. Arias' petition made the legal argument that the Board lacks the authority to place him on probation.

After discussion the Board voted unanimously to deny this petition.

ROBERT DIETZ

Mr. Dietz was present with Attorney Robert Crabill.

Ms. Guillemette presented this case stating that Mr. Dietz's application for certification for a registered license was denied at the September 2005 meeting of the Board. Mr. Dietz received a Notice of Intent to Deny on January 23, 2006. Mr. Dietz timely requested Board reconsideration on January 30, 2006 and supplied the Board with some additional information.

After discussion the Board voted unanimously to approve Mr. Dietz's Application.

HEATHER DAWN MICHAEL
