REVIEW OF MINUTES

• Final Action – August, 2005

The Board voted unanimously to approve these minutes.

EXECUTIVE DIRECTOR'S REPORT

Mr. Vaccaro reported that 1972 complaints were added and 740 were found legally sufficient. There were 399 unlicensed complaints that were found legally sufficient. 792 Investigations were assigned and 289 investigations were completed. There were approxiamately 200 mediations assigned, 90 mediations completed, 6 notices of non-compliance issued and 77 citations filed.

CHAIRMAN'S REPORT

Ms. Brown thanked the Board Members for all of their hard work and patience while preparing for and attending the board meetings.

The Board voted unanimously to excuse Ms. Kane's absence.

PROSECUTING ATTORNEY'S REPORT

For the month of August, there were 244 cases in Legal, 89 were set for Probable Cause, 143 cases had Probable Cause/Administrative Complaints filed, 52 cases were ready for default and 75 cases had Stipulations executed or Informal hearings requested. Also, 95 cases had requested Formal hearings, 6 cases were referred to DOAH, 64 cases are awaiting Final Orders, and 9 cases are in settlement negotiations. For the month of August 2005, 145 cases were closed.

ATTORNEY GENERAL'S REPORT

A. Advanced Benefits Inc – Informal Hearing

Ron Mikolajckz was present. Ms. Guillemette presented this case stating that Advanced Benefits, Inc.'s application for course approval was denied at the May 2005 Board Meeting because it constitutes sales of PEO services and is not related to contracting as required by rule.

Advanced Benefits, Inc. has submitted additional information and is requesting that the board reconsider the application.

The Board voted to approve this course.

B. Professional Training and Consultants Inc – Informal Hearing

Dean Jarvis was present. Ms. Guillemette presented this case stating that Professional Training and Consultants, Inc.'s application for continuing education courses were considered at the July 2005 Board Meeting. The courses "NFIP: Risk Identification, Floodplain Management & Flood Insurance," and "Introduction to the Coastal Construction Manual," were denied as not relating to contracting.

The Board voted to uphold the denial of the course "NFIP: Risk Identification, Floodplain Management & Flood Insurance", but to approve the course "Introduction to the Coastal Construction Manual."

C. Richard Hinshaw – Informal Hearing

Mr. Richard Hinshaw and Michael Dravo were present. Ms. Guillemette presented this case stating Mr. Hinshaw was scheduled before the Additional Business Entities Committee of the Construction Industry Licensing Board in August 2005.

This application was denied because he did not appear.

Mr. Dravo has requested that the Board reconsider Mr. Hinshaw's application.

The Board voted to uphold the denial of this application.

D. Yanuario Arias – Informal Hearing

Yanuario & Molina Arias were present. Ms. Guillemette presented this case stating that Mr. Arias's application went before the Applications committee at the June 2005 Board meeting.

The application was denied based on failure to provide proof of Civil Rights. Mr. Arias argues that the Civil Rights provision does not apply to him since he is not a U.S. Citizen.

The Board voted to uphold the denial of this application.

E. Gold Coast vs. CILB – Settlement for Payment of Fees and Costs

No one was present. Ms. Guillemette presented this case stating that Gold Coast was successful with their challenge to both the proposed changes and the existing rule 61G4-15.005, as it relates to net worth. The Administrative Law Judge ordered that the Board, unless it shows that its actions were substantially justified or special circumstances exist which would make the award unjust, pay cost and fees to Gold Coast.

Gold Coast filed a motion for fees and costs in the amount of \$34,248. Gold Coast later offered a settlement on \$29,248.

Hearing on that motion was set for September 2, 2005.

Counsel for the Board met with Department of Business of Professional Regulation General Counsel regarding the office. The Department suggested a counteroffer of \$26,000, subject to Board approval.

That offer was relayed to Counsel for Gold Coast, understanding that it was subject to Board approval.

The Board voted to approve this counteroffer of \$26,000.
