#### PROSECUTING ATTORNEY'S REPORT - APRIL HAMMONDS

Ms. Hammonds gave the following report:

For the month of October 2007, the overall case load was 2,017, down from 2,090 in September of 2007 and up from 1,587 in October 2006.

There were 653 cases to be reviewed in Legal, 263 cases set for probable cause, and 207 cases where probable cause had been found/administrative complaints filed. 157 cases were ready for default, 17 cases had stipulations executed/informal hearings requested, and 162 had requested formal hearings. There were 29 cases referred to DOAH, 148 cases in settlement negotiations, 199 cases awaiting final orders, and 182 cases set for Board presentation. There were 0 cases under appeal and 0 cases reopened. 297 cases were closed for the month of October.
