Mr. Milne thanked the Board and announced his new permanent role with the Board.

Mr. Biggins informed the Board that the legislative session would start next week and discussed appointments with the Board.

With nothing further to report the Board voted unanimously to approve this report.

CHAIRMAN'S REPORT- Aaron Boyette

HEARING AND PETITIONS

CARPENTER, JASON – REQUEST FOR INFORMAL HEARING

Mr. Carpenter was present.

Mr. Barnhart presented this case stating Mr. Carpenter's application for a Certified Building Contractor's license was denied at the September 2019 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in October of 2019. Mr. Carpenter timely requested an informal hearing.

After discussion, the Board voted to vacate the previous denial and to approve the application.

CICERONI, DYLAN – PETITION FOR DECLARATORY STATEMENT

Mr. Ciceroni was not present.

Mr. Barnhart presented this case stating Mr. Ciceroni filed a petition for a Declaratory Statement on October 29, 2019. The petition was noticed in the Florida Administrative Register on November 7, 2019. Mr. Barnhart noted the petitioner asked the Board whether there are state licensing requirements for providing labor services to trenching and installing trench sleeves.

After discussion, the Board voted to decline to answer the petition.

CONTRERAS, ALVARO – REQUEST FOR INFORMAL HEARING

Mr. Contreras was not present.

Mr. Barnhart presented this case stating Mr. Contreras' application for a Certified Roofing Contractor's license was denied at the August 2019 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code; and because the applicant is currently under investigation or prosecution, contrary to section 455.213 (3), Florida Statutes. The Notice of Intent to Deny was filed in September of 2019. Mr. Contreras timely requested an informal hearing.

After discussion, the Board voted to continue the hearing for one year or until such time as the objection to the application has been removed by the Office of the General Counsel.

FIGRELLA, CHRISTOPHER – REQUEST FOR INFORMAL HEARING

Mr. Fiorella was present.

Mr. Barnhart presented this case stating Mr. Fiorella's application for a Certified Specialty Structure Contractor's license was denied at the September 2019 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in October of 2019. Mr. Fiorella timely requested an informal hearing.

After discussion, the Board voted to vacate the previous denial and to approve the application.

FORAN, WILLIAM – PETITION FOR VARIANCE & WAIVER

Mr. Foran was not present.

Mr. Barnhart presented this case stating Mr. Foran filed a petition for variance and waiver on September 17, 2019. The petition was noticed in the Florida Administrative Register on October 22, 2019. Mr. Barnhart noted the petitioner does not cite a rule, but appears to be asking the Board for a variance of Rule 61G4-16.005, and to extend the duration of validity for his passing examination scores.

After discussion, the Board voted to deny the petition as the Board found the petitioner failed to establish that application of the Rule to the petitioner's circumstances would violate the principles of fairness or impose a substantial hardship .
