PROSECUTING ATTORNEY'S REPORT – Ian Brown

Mr. Brown gave the following report:

For the month of January 2016, the overall license activity case load was 788, down from 739 in December of 2015, and up from 686 in January 2015.

There were 603 cases currently in Legal to be reviewed, 38 cases set for probable cause, 22 cases where probable cause had been found/administrative complaints filed, 1 settlement stipulation approved, 3 informal hearings requested, 0 cases awaiting outside action, 16 cases ready for default, 27 formal hearings requested, 7 cases referred to DOAH, 0 cases in settlement negotiations, 0 case pending board date, 29 cases set for board presentation, 42 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of January 2016, 45 cases were closed.

GLENN AMERSON – REQUEST FOR INFORMAL HEARING

Mr. Dolan presented this case stating Mr. Amerson’s application to qualify IN2IT Homes LLC, was previously reviewed and considered at the September 2015 meeting of the Board. The application was denied stating as grounds: the applicant failed to appear as required by Rule 61G4-15.0021, Florida Administrative Code, and the applicant failed to demonstrate he would have the ability to properly supervise the construction work and business activities of the organization, as required by section 489.119, Florida Statutes. The Notice of Intent to Deny was filed in October of 2015. Mr. Amerson timely requested board reconsideration.

After discussion, the Board voted to uphold the denial

BANKS BROTHERS CONSTRUCTION – PETITION FOR DECLARATORY STATEMENT

A representative of Banks Brothers Construction was not present.

Mr. Dolan presented this case stating that Banks Brothers Construction filed a petition for Declaratory Statement on December 12, 2015. The petition was noticed in the Florida Administrative Register on January 7, 2016. Mr. Dolan noted the petitioner asks the Board whether there is a licensing solution for their company other than 61G4-15.001, Florida Administrative Code, which is excessive to their specific work as a tenant improvement contractor.

After discussion, the board voted to decline to answer due to the petition being facially insufficient as it does not meet with the essential requirements of law.

CHRISTOPHER SHAWN BARHAM – REQUEST FOR INFORMAL HEARING

Mr. Barham was present

Mr. Dolan presented this case stating Mr. Barham’s application for a Certified Mechanical Contractor’s license, was previously reviewed and considered at the June 2015 meeting of the Board. The application was denied for failure to demonstrate the required experienced, pursuant to section 489.111, Florida Statute, and Rule 61G4-15.001 Florida Administrative Code. The Notice of Intent to Deny was filed in July of 2015. Mr. Barham timely requested board reconsideration.

After discussion, the board voted to uphold the denial

BRADLEY FOSTER – REQUEST FOR INFORMAL HEARING

Mr. Foster was not present.

Mr. Dolan presented this case stating Mr. Foster’s application for a change of status for a Registered Pool/Spa Servicing Contractors’ license was denied at the July 2015 meeting of the Board for failure to

sufficiently demonstrate financial stability, as required by Florida Statute 489.115, and Rule 61G4-15.006, Florida Administrative Code. The Notice of Intent to Deny was filed in August of 2015. Mr. Foster timely requested board reconsideration.

After discussion, the board voted to grant the applicant a 60 day continuance.

DAVID WILLIAM GRAF – REQUEST FOR INFORMAL HEARING

Mr. Graf was present

Mr. Dolan presented this case stating Mr. Graf's application for a Certified Pool/Spa Servicing Contractor's license, was previously reviewed and considered at the October 2015 meeting of the Board. The application was denied stating as grounds: the applicant failed to demonstrate the required experience necessary for a certified pool/spa servicing contractor's license pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in November of 2015. Mr. Graf timely requested board reconsideration.

After discussion, the Board voted to vacate the previous denial and approve the application

THOMAS CASEY HALL – REQUEST FOR INFORMAL HEARING

Mr. Hall was present.

Mr. Dolan presented this case stating Mr. Hall's application for a Certified Building Contractors' license was denied at the October 2015 meeting of the Board for failure to demonstrate required experience, as required by Florida Statute 489.111 and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in November of 2015. Mr. Hall timely requested board reconsideration.

After discussion, the board voted to vacate the denial and approve the downgrade to a Certified Residential License.

JAMES R. MACON SR. – REQUEST FOR INFORMAL HEARING

Mr. Macon was present

Mr. Dolan presented this case stating Mr. Macon's application to qualify F.M. Harvey Construction Co., Inc., was previously reviewed and considered at the November 2015 meeting of the Board. The application was denied stating as grounds: the applicant failed to appear as required by Rule 61G4-15.0021, Florida Administrative Code, and the applicant failed to demonstrate he would have the ability to properly supervise the construction work and business activities of the organization, as required by section 489.119, Florida Statutes. The Notice of Intent to Deny was filed in January of 2016. Mr. Macon timely requested board reconsideration.

After discussion, the Board voted to vacate the previous denial and approve the application

JEFFREY MCGARVEY – REQUEST FOR INFORMAL HEARING

Mr. McGarvey was present.

Mr. Dolan presented this case stating Mr. McGarvey's application for a Certified General Contractor's license was denied at the October 2015 meeting of the Board for failure to demonstrate required experience, pursuant to Florida Statute 489.111 and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in November of 2015. Mr. McGarvey timely requested board reconsideration.

After discussion, the Board voted to vacate the previous denial, and approve the application.

CLIFFORD MOORE JR. – REQUEST FOR INFORMAL HEARING

Mr. Moore was present.

Mr. Dolan presented this case stating Mr. Moore's application for a Certified General Contractor's license was denied at the November 2015 meeting of the Board due to the Department having open enforcement against the applicant contrary to section 455.213(3), Florida Statutes. The Notice of Intent to Deny was filed in January of 2016. Mr. Moore timely requested board reconsideration.

After discussion, the Board voted to vacate the previous denial, and approve the application.

ARIEL RODRIGUEZ – REQUEST FOR RECONSIDERATION

Mr. Rodriguez was not present, and requested a 60 day continuance.

After discussion, the Board voted to grant the 60 day continuance

SGS CONTRACTING SERVICES – PETITION FOR DECLARATORY STATEMENT

A representative of SGS Contracting Services was not present.

Mr. Dolan presented this case stating that SGS Contracting Services filed a petition for Declaratory Statement on November 6, 2015. The petition was noticed in the Florida Administrative Register on November 13, 2016. Mr. Dolan noted the petitioner asks the Board whether pursuant to Sections 489.105(3) (a), 489.105 (n) and 489.113 (3) (d) a Certified General Contractor and/or a Certified Underground Utility and Excavation Contractor can install pre-engineered and pre-fabricated PVC or fiberglass ductwork integral and connected to an odor control system at a municipal treatment and/or collection facility without having to subcontract the work to a mechanical, plumbing, or air conditioning contractor.

After discussion, the board voted to decline to answer due to the petition not referring to a particular set of circumstances, and that it seeks to determine the conduct of another person.

HAROLD WALKER – PETITION FOR VARIANCE & WAIVER

Mr. Walker was not present.

Mr. Dolan presented this case stating that Mr. Walker filed a petition for Variance or Waiver on December 30, 2015. The petition was noticed in the Florida Administrative Register on January 14, 2016. Mr. Dolan noted the petitioner asks the Board for a variance from or a waiver of Rule 61G4-16.005, Florida Administrative Code, which requires for the purpose of certification, a passing grade

shall be valid only for a period of four (4) years from the date the list of successful candidates is approved by the Board.

After discussion, the Board voted to deny the petition because the Petitioner has not shown how application of the rule creates a substantial hardship or violates principles or fairness.

CHRISTOPHER WRIGHT – PETITION FOR DECLARATORY STATEMENT

Mr. Wright was present.

Mr. Dolan presented this case stating that Christopher Wright filed a petition for Declaratory Statement on December 30, 2015. The petition was noticed in the Florida Administrative Register on January 13, 2016. Mr. Dolan noted the petitioner asks the Board to clarify the scope, capability and requirements for the Class Code CV (Solar Contractor) license endorsement in Florida.

After discussion, the board voted to decline to answer due to the petition being facially insufficient as it does not meet with the essential requirements of law and because the petitioner lacks standing.
