PROSECUTING ATTORNEY'S REPORT - PAUL WATERS

ATTORNEY GENERAL'S REPORT - DANIEL BIGGINS

IRA ARNOLD - REQUEST FOR INFORMAL HEARING

Mr. Arnold was present.

Mr. Biggins presented this case stating Mr. Arnold's application for initial issuance of a certified general contractor's license was denied at the January 2013 meeting of the board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code, and failure to sufficiently demonstrate financial stability and responsibility, pursuant to Section 489.115, Florida Statutes and Rule 61G4-15.006, Florida Administrative Code. The Notice of Intent to Deny was filed in February of 2013. Mr. Arnold timely requested board reconsideration, and requested the board allow him to obtain a building contractor's license.

After discussion the board granted Mr. Arnold a 60 day continuance to allow him to provide further documentation relating to his experience and financial stability.

MICHAEL CANTRELL - REQUEST FOR INFORMAL HEARING

Mr. Cantrell was present.

Mr. Biggins presented this case stating Mr. Cantrell's application for a change of status of his building contractor's license was denied at the November 2012 meeting of the board as the applicant was the subject of prior discipline for violations of Chapter 455 and Chapter 489, Florida Statutes, and/or Chapter 61G4, Florida Administrative Code, and has failed to demonstrate compliance with imposed discipline, and for having been convicted, found guilty of, or entered a plea of nolo contendre to crimes related to the practice of contracting, contrary to Sections 455.227 (1)(c) and 489.129 (1)(b), Florida Statutes. The Notice of Intent to Deny was filed in January of 2013. Mr. Cantrell timely requested reconsideration and requested the board vacate the denial of the application and allow him to withdraw the application.

After discussion the board voted to vacate the denial of the application and allowed Mr. Cantrell to withdraw his application.

CURT DORSEY - REQUEST FOR INFORMAL HEARING

Mr. Dorsey was present.

Mr. Biggins presented this case stating Mr. Dorsey's application to qualify an additional business entity was denied at the February 2013 meeting of the board for failing to appear as required by Rule 61G4-15.0021, Florida Administrative Code. The Notice of Intent to Deny was filed in March of 2013. Mr. Dorsey timely requested reconsideration.

After discussion the board voted to approve the application.

MARK FETHERMAN – PETITION FOR VARIANCE AND WAIVER

Mr. Fortier timely requested board reconsideration, and requested the board vacate the denial of the application and allow him to withdraw the application.

After discussion the board voted to vacate the denial of the application and allowed Mr. Fortier to withdraw his application.

The Notice of Intent to Deny was filed in February of 2013. Mr. Fry timely requested board reconsideration.

After discussion the board voted to grant Mr. Fry a 60 day continuance to allow him to provide additional documentation relating to his experience.

MICHAEL GROSS - REQUEST FOR INFORMAL HEARING

Mr. Biggins presented this case stating Mr. Gross' application for initial issuance of a certified mechanical contractor's license was denied at the January 2013 meeting of the board for failing to demonstrate the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in February of 2013. Mr. Gross timely requested board reconsideration.

After discussion the board voted to approve the application as a downgrade to a Class B air conditioning contractor's license.

MIGUEL MAGALLANES - REQUEST FOR INFORMAL HEARING

ANDRE PEREZ – PETITION FOR VARIANCE AND WAIVER AND REVIEW OF APPLICATION

Mr. Biggins noted the petitioner seeks a waiver of Rule 61G4-16.0015, Florida Administrative Code, so that he may be exempt from having to take the Business and Finance portion of the examination with an inactive license. After additional discussion the board concluded that Mr. Perez did not have the required experience, pursuant to Section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. After further discussion Mr. Perez withdrew his application.

Ms. Watts asked if the board would ever consider the idea of possibly allowing residential property owners who rent a property to be allowed to contract for their own repairs on that property. Ms. Watts said it is happening anyway and it would be for the best to get these property owners into compliance. Mr. Winters reminded the board that they cannot be a "lobbying" body and propose changes to the statutes. Something like that should be proposed by a local or state association. This particular issue would be a change in the statutes, which the board does not have the authority to change.

Mr. Boyette asked if the Department could do something to make sure that licensed contractors are including their license numbers on their social media pages. Mr. Winters stated that he had been previously made aware of the issue by Mr. Hussey and that the Department put some information on the website to remind contractors that their license numbers need to be included on social media pages. Mr. Waters stated that if anyone comes across a social media page that does not include a license number, to let either himself or Mr. Winters know and they will initiate a complaint.
