The meeting was called to order by Brian Cathey, Chair, at 9:03am. Mr. Cobb gave the Invocation. Mr. Lawson led the Pledge of Allegiance.

EXECUTIVE DIRECTOR'S REPORT - Drew Winters

Mr. Winters gave the following report:

PROSECUTING ATTORNEY'S REPORT - KYLE CHRISTOPHER

There were 371 cases currently in Legal to be reviewed, 9 cases set for probable cause, 23 cases for which probable cause had been found/administrative complaints filed, 1 settlement stipulation approved, 2 informal hearings requested, 8 cases awaiting outside action, 10 cases ready for default, 28 formal hearings requested, 2 cases referred to DOAH, 4 cases in settlement negotiations, 1 case pending a Board date, 25 cases set for Board presentation, 35 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of March 2014, 72 cases were closed.

For the month of March 2014, the overall unlicensed activity case load was 515, down from 569 in February 2014.

There were 460 cases currently in Legal to be reviewed, 10 cases where administrative complaints had been filed, 1 settlement stipulation approved, 10 informal hearings requested, 0 cases awaiting outside action, 15 cases ready for default, 17 formal hearings requested, 0 cases referred to DOAH, 2 cases in settlement negotiations, 0 cases awaiting final orders, 0 cases under appeal and 0 cases had been reopened.

For the month of March 2014, 64 cases were closed.

KEITH ANDRADE - REQUEST FOR INFORMAL HEARING

Mr. Barnhart presented this case stating Mr. Andrade's application for initial issuance of a certified residential contractor's license was denied at the November 2013 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in January of 2014. Mr. Andrade timely requested Board reconsideration.

After discussion, the Board voted to vacate the previous denial and to approve the application.

JORGE BELLO DIAZ - REQUEST FOR INFORMAL HEARING

The Notice of Intent to Deny was filed in October of 2013. Mr. Bello Diaz timely requested board reconsideration.

The Notice of Intent to Deny was filed in April of 2014. Mr. Checho timely requested Board reconsideration.

Mr. Barnhart presented this case stating Mr. Cook's application for initial issuance of a certified general contractor's license was denied at the January 2014 meeting of the Board for failing to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in February of 2014. Mr. Cook timely requested Board reconsideration.

After discussion, the Board voted to uphold the previous denial.

DAVID CZOSCHKE - REQUEST FOR INFORMAL HEARING

Mr. Barnhart presented this case stating Mr. Czoschke's application to qualify an additional business entity was denied at the January 2014 meeting of the Board for failing to demonstrate the applicant would properly supervise the construction work, as required by section 489.119, Florida Statutes. The Notice of Intent to Deny was filed in February of 2014. Mr. Czoschke timely requested Board reconsideration.

After discussion, the Board voted to vacate the previous denial and approve the application contingent upon the applicant providing proof of at least 20% ownership.

DOUGLAS GEIS - REQUEST FOR INFORMAL HEARING

Mr. Barnhart presented this case stating Mr. Geis' application for initial issuance of a certified general contractor's license was denied at the November 2013 meeting of the Board for failing to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida

GERALD LASCHOBER – PETITION FOR VARIANCE OR WAIVER

Mr. Barnhart presented this case stating that Mr. Laschober filed a petition for variance or waiver on February 14, 2014. The petition was noticed in the Florida Administrative Register on February 24, 2014. Mr. Barnhart noted the petitioner is licensed by the Board as a certified general contractor and is

requesting a variance or waiver of the financial responsibility and stability requirements of 61G4-15.006, Florida Administrative Code.

After discussion, the Board voted to deny the request for variance or waiver.

Petitioner indicates that most projects are single story, 3000 square foot stores.

After discussion, the Board voted that the definition of "building contractor" in section 489.105(3)(b), F.S., includes the ability to construct new buildings as described in the petitioner's request for declaratory statement.

DAVID OLDACK - REQUEST FOR INFORMAL HEARING

Mr. Barnhart presented this case stating Mr. Oldack's application for initial issuance of a certified solar contractor's license was denied at the January 2014 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in February of 2014. Mr. Oldack timely requested Board reconsideration.

After discussion, the Board voted to uphold the denial.

CARLOS OTERO - REQUEST FOR INFORMAL HEARING

Mr. Otero was present.

Mr. Barnhart presented this case stating Mr. Otero's application to qualify an additional business was denied at the January 2014 meeting of the Board for failure to demonstrate the qualifying agent would properly supervise the construction work and business activities, as required by section 489.119, Florida Statutes.
