The meeting was called to order by Roy Lenois, Chair, at 9:20am. Ms. Watts gave the Invocation. Mr. Sheehan led the Pledge of Allegiance.

EXECUTIVE DIRECTOR'S REPORT – Daniel Biggins

Mr. Biggins gave the following report:

Mr. Biggins informed the board that the Department is currently in the process of moving to the old Department of Corrections Building off of Blairstone Road and to please bear with us over the next few weeks as we transition.

Legislative update: HB535 has been signed and will go into effect July 1, 2016. Senate Bill (SB104) is on the Governor's Desk- this is the Veteran's Bill, the Department will create a specific application just for veterans, as well as the experience requirements for veterans under ECLB and CILB.

Mr. Evetts gave the following report: I have read HB535 and it's changed a lot of things, so be sure you read up on it.

PROSECUTING ATTORNEY'S REPORT - IAN BROWN

Mr. Brown gave the following report:

For the month of March 2016, the overall license activity case load was 940, up from 848 in February of 2016, and up from 624 in March of 2015.

There were 711 cases currently in Legal to be reviewed, 7 cases set for probable cause, 33 cases where probable cause had been found/administrative complaints filed, 5 settlement stipulations approved, 3 informal hearings requested, 0 cases awaiting outside action, 18 cases ready for default, 41 formal hearings requested, 4 cases referred to DOAH, 0 cases in settlement negotiations, 0 cases pending board date, 72 cases set for board presentation, 46 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of March 2016, 39 cases were closed.

ATTORNEY GENERAL'S REPORT – Douglas Dolan

MATTHEW GLENN AUSTIN - REQUEST FOR INFORMAL HEARING

Mr. Austin was not present.

Mr. Dolan presented this case stating Mr. Austin's application for a Certified General Contractors' license was denied at the January 2016 meeting of the Board for failure to demonstrate required experienced, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2016. Mr. Austin timely requested board reconsideration.

After discussion, the Board voted to grant the applicants request and vacate the previous denial and allow him to withdraw the application.

LEWIN EARL CAMPBELL - REQUEST FOR INFORMAL HEARING

Mr. Campbell was not present.

Mr. Dolan presented this case stating Mr. Campbell's application for a Certified Roofing Contractor was denied at the September 2015 meeting of the Board for failure to demonstrate required experienced, as required by Florida Statute 489.111 and 61G4-15.001 Florida Administrative Code. The Notice of Intent to Deny was filed in October of 2014. Mr. Campbell's timely requested board reconsideration.

After discussion, the Board voted to uphold the denial.

CLIMBWORKS - PETITION FOR DECLARATORY STATEMENT

A representative of Climbworks was not present.

Mr. Dolan presented this case stating Climbworks filed a petition for a declaratory statement on February 8, 2016. The petition was noticed in the Florida Administrative Register on February 23, 2016. Mr. Dolan noted the petitioner asks the Board's opinion as to the applicability of 489.105, F.S., as it applies to the activities of installing ground anchors, utility poles, and backfilling.

After discussion, the Board voted to decline to answer, as the petitioner is not substantially affected and does not have standing to request a declaratory statement.

ROGER FEICHT – PETITION FOR DECLARATORY STATEMENT

Mr. Feicht was not present.

Mr. Dolan presented this case stating Mr. Feicht filed a petition for a declaratory statement on February 22, 2016. The petition was noticed in the Florida Administrative Register on December 23, 2014. Mr. Dolan noted the petition seeks the Board's to issue a declaratory statement that there is no time deadline for the Construction Related Complaint Package (DBPR CILB 4355) or Uniform Complaint Form- Construction (DBPR 0070) that would bar or otherwise limit a complaint based on conduct occurring during the years 2007, 2008, and 2009.

After discussion, the Board voted the petition had no standing, and declined to answer stating grounds as the petitioner is not a licensee, and petition may essentially be litigation.

BRADLEY FOSTER - REQUEST FOR INFORMAL HEARING

Mr. Foster was present with counsel.

Mr. Dolan presented this case stating Mr. Foster's application for a change of status for a Registered Pool/Spa Servicing Contractors' license was denied at the July 2015 meeting of the Board for failure to sufficiently demonstrate financial stability, as required by Florida Statute 489.115, and Rule 61G4-15.006, Florida Administrative Code.. The Notice of Intent to Deny was filed in August of 2015. Mr. Foster timely requested board reconsideration.

After discussion, the board voted to grant the applicant a 180 day continuance.
