PROSECUTING ATTORNEY'S REPORT - Ian Brown

Mr. Brown gave the following report:

For the month of March 2017, the overall license activity case load was 908, down from 971 in February of 2017, and down from 940 in March of 2016.

There were 431 cases currently in Legal to be reviewed, 193 cases awaiting probable cause panel/initial review complete, 18 cases set for probable cause, 52 cases where probable cause had been found/administrative complaints filed, 3 settlement stipulation approved, 9 informal hearings requested, 0 cases awaiting outside action, 30 cases ready for default, 78 formal hearings requested, 2 cases referred to DOAH, 21 cases in settlement negotiations, 0 case pending board date, 41 cases set for board presentation, 30 cases awaiting final orders, 0 cases under appeal and 0 cases had been reopened.

For the month of March 2017, 204 cases were closed.

RICHARD ANGERHOFER - REQUEST FOR INFORMAL HEARING

The informal hearing request was pulled from the agenda.

ROGER D. CASEY – PETITION FOR DECLARATORY STATEMENT

Mr. Casey was present.

Ms. Clark presented this case stating Mr. Casey filed a petition for declaratory statement on November 14, 2016. The petition was noticed in the Florida Administrative Register on January 6, 2017. Ms. Clark noted the petition seeks the Board's clarification as to whether a Certified Mechanical Contractor is authorized to perform gas piping to equipment or appliances exterior of a building as well as inside?

After discussion, the board voted the petitioner has standing. After further review, the Board declines to answer as this request is based on past behavior, conduct of another individual, and the statute is clearly stated.

WILLIAM CLARK CLIFFORD CRYER - PETITION FOR DECLARATORY STATEMENT

Mr. Cryer was present with counsel.

Ms. Clark presented this case stating Mr. Cryer filed a petition for declaratory statement on March 1, 2017. The petition was noticed in the Florida Administrative Register on March 45, 2017. Ms. Clark noted the petition seeks the Board's clarification as to whether an underground utility and excavation contractor license, as its scope is defined in 489.105(3)(n), Florida Statutes, is required when the only work being done is the installation of casing pipe or conduit accomplished through a trenchless technology technique such as directional drilling, auger boring, jacking and boring, micro tunneling, pipe ramming or pilot tube guided boring.

After discussion, the board voted the petitioner has standing. After further review, the Board voted to answer the declaratory statement that an underground utility and excavation contractor license is required to perform this scope of work.

JENNIFER JORDAN- REQUEST FOR INFORMAL HEARING

Ms. Jordan was present with counsel.

Ms. Clark presented this case stating Ms. Jordan's application for a Certified Building Contractors' license was denied at the May 2016 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in July of 2016. Ms. Jordan timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application.

JOHN PAUL MERINO - REQUEST FOR INFORMAL HEARING

Mr. Merino was not present.

Ms. Clark presented this case stating Mr. Merino's application for a Certified General Contractors' license was denied at the October 2016 meeting of the Board for failure to demonstrate financial stability and responsibility, pursuant to section 489.115, Florida Statutes and Rule 61G4-15.006, Florida Administrative Code. The applicant has been convicted, found guilty of, or entered a plea of nolo contendere to crimes related to the practice of contracting, contrary to sections 455.227(1)(c) and 489.129(1) (b), Florida Statutes. The Notice of Intent to Deny was filed in December of 2016. Mr. Merino timely requested board reconsideration.

After discussion, the board voted to uphold the denial.
