Division II has been added into the Recovery Fund and the Recovery Fund notice must appear in all contracts effective July 1, 2016 with Division II claims being accepted January 1, 2017.

CHAIRMAN'S REPORT - Jim Evetts

Mr. Evetts gave the following report:

With the new information we received from the General Counsel's presentation this week, we're beginning to feel a little more comfortable on the Anti-Trust information previously brought before the Board.

With nothing further to report the board voted unanimously to approve this report.

PROSECUTING ATTORNEY'S REPORT - IAN BROWN

Mr. Brown gave the following report:

For the month of April 2016, the overall license activity case load was 940, same as 940 in March of 2016, and up from 661 in April 2015.

There were 707 cases currently in Legal to be reviewed, 9 cases set for probable cause, 37 cases where probable cause had been found/administrative complaints filed, 3 settlement stipulation approved, 2 informal hearings requested, 0 cases awaiting outside action, 30 cases ready for default, 50 formal hearings requested, 2 cases referred to DOAH, 7 cases in settlement negotiations, 0 case pending board date, 28 cases set for board presentation, 65 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of April 2016, 101 cases were closed.

With nothing further to report the board voted unanimously to approve this report.

ATTORNEY GENERAL'S REPORT – Douglas Dolan

FRANK M. ADAMS - RECONSIDERATION

Mr. Adams was not present.

Mr. Dolan presented this case stating Mr. Adams' application for a Certified Pool/Spa Contractors' license was denied at the February 2015 meeting of the Board for failure to demonstrate he had passed an examination that is substantially equivalent to the required Florida Certification examination. The Notice of Intent to Deny was filed in March of 2015. Mr. Adams timely requested board reconsideration.

After discussion, the Board voted to uphold the denial.

ROBERT GARZA - REQUEST FOR INFORMAL HEARING

Mr. Garza was not present, and requested a 120 day continuance.

After discussion, the Board voted to grant the 120 day continuance.

INDIANA INDUSTRIAL SERVICES - PETITION FOR DECLARATORY STATEMENT

Representatives from Indiana Industrial Services were present. (Mr. Smith)

Mr. Dolan presented this case stating Indiana Industrial Services filed a petition for a declaratory statement on March 25, 2016. The petition was noticed in the Florida Administrative Register on April 1, 2016. Mr. Dolan noted the petition seeks the Board's clarification as to which, if any, license would be required for their company to do work within the State of Florida, as addressed in DS 2016-024.

After discussion, the Board voted to decline to answer the declaratory statement, because the petitioner is not a substantially affected party and does not have standing to request a declaratory statement.

EDGAR L. LANEY JR. - PETITION FOR DECLARATORY STATEMENT

Mr. Laney was not present.

Mr. Dolan presented this case stating Mr. Laney filed a petition for a declaratory statement on March 17, 2016. The petition was noticed in the Florida Administrative Register on March 24, 2016. Mr. Dolan noted the petition seeks the Board's clarification as to whether an Underground Utility Contractor is qualified to install sewer services to a Modular home.

After discussion, the Board voted to decline to answer, as the petition relates to an ongoing controversy, that the question is already answered in statute, and that the Petition is attempting to determine conduct of another.

YAHVE MONTALVO - REQUEST FOR INFORMAL HEARING

Mr. Montalvo was present with counsel.

Mr. Dolan presented this case stating Mr. Montalvo's application for a Certified Building Contractors' license denied at the January 2016 meeting of the Board for failure to demonstrate required experience, as required by Florida Statute 489.111, and 61G4-15.001 Florida Administrative Code and the applicant has been convicted, found guilty of, or entered a plea of nolo contendere to crimes related to the practice of contracting, contrary to sections 455.227(1)(c) and 489.129 (1)(b), Florida Statutes The Notice of Intent to Deny was filed in April of 2016. Mr. Montalvo timely requested board reconsideration.

After discussion, the Board voted to vacate the previous denial and approve the application.

TONY L PHILLIPS – RECONSIDERATION

Mr. Phillips was not present.

Ms. McDonald presented this case stating Mr. Phillip's application for a Certified Building Contractors license was denied at the June 2015 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in July of 2015. Mr. Phillips timely requested board reconsideration.

After discussion, the Board voted to accept the ALJ recommended order as an order of its own, and denied the application.

STEVEN BARWICK RIVERS - REQUEST FOR INFORMAL HEARING

Mr. Rivers was present.

Mr. Dolan presented this case stating Mr. Rivers application to qualify Austin Commercial, LP as an additional business was denied at the January 2016 meeting of the Board for failure to appear, as required by Rule 61G4-15.0021, Florida Administrative Code. The Notice of Intent to Deny was filed in April of 2016. Mr. Rivers timely requested board reconsideration.

After discussion, the Board voted to vacate the previous denial and approve the application.

MIGUEL TOLMO - REQUEST FOR INFORMAL HEARING

Mr. Tolmo was present.

Mr. Dolan presented this case stating Mr. Tolmo's application for a Certified Building Contractors license was denied at the January 2016 meeting of the Board as the applicant for endorsement did not demonstrate he has passed an examination that is substantially equivalent to the required Florida certification examination; that he has a license in a state whose criteria are substantially similar to Florida's or that he has attained the experience requirements for certification in Florida, as required by section 489.115(3), Florida Statutes. The Notice of Intent to Deny was filed in April of 2016. Mr. Tolmo timely requested board reconsideration.

After discussion, the Board voted to vacate the previous denial and approve the application.

RYAN ZURHEIDE - PETITION FOR VARIANCE & WAIVER

Mr. Zurheide was not present.

Mr. Dolan presented this case stating that Mr. Zurheide filed a petition for Variance or Waiver on March 23, 2016. The petition was noticed in the Florida Administrative Register on March 24, 2016. Mr. Dolan noted the petitioner asks the Board for a variance from or a waiver of four year duration of validity of examination scores.

After discussion, the Board voted to deny the petition because the petitioner did not demonstrate a substantial hardship, does not violate principles of fairness, or is affected in a manner significantly different from the way the rule affects other similarly situated persons who are subject to the rule.
