PROSECUTING ATTORNEY'S REPORT - Ian Brown

Mr. Brown gave the following report:

For the month of June 2016, the overall license activity case load was 1028, up from 980 in May of 2016, and up from 682 in June 2015.

There were 744 cases currently in Legal to be reviewed, 5 cases set for probable cause, 61 cases where probable cause had been found/administrative complaints filed, 4 settlement stipulation approved, 4 informal hearings requested, 0 cases awaiting outside action, 31 cases ready for default, 50 formal hearings requested, 2 cases referred to DOAH, 32 cases in settlement negotiations, 0 case pending board date, 23 cases set for board presentation, 72 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of June 2016, 121 cases were closed.
