## RULES/PUBLIC/LEGISLATIVE COMMITTEE: SPECIAL DISCUSSION

The Rules/Public/ Legislative Committee members convened for discussion on August 13, 2015 from 10:04am- 12:28pm. Ms. Watts led the meeting.

Rules Discussion regarding A/C contractors and pool heaters: Statutory provisions 489.105 (3)(f) and (g)

Public comment was made by: Mr. Dudley, Ms. Hatfield, Mr. Tawney, Mr. Cotney, Mr. Sims (Rick), Mr. Moss (Andy), Mr. Evans, FSPA representative, Mr. Howard (Rick), Mr. Sanger (Rob), Mr. Kirsch USPA

Board Members: Ms. Watts, Mr. Lenois, Mr. Evetts, (Board Counsel: Doug Dolan)

#### **Comments:**

- Mr. Dudley referenced DS 2012-024 of Mr. Tawney. The question posed in DS 2012-024 is:
   "Can a licensed Class A or B air-conditioning contractor contract and install a heat pump for a swimming pool or spa?"
- The specific concern addressed in DS 2012-024 was that installation of a pool heater could increase water flow and pressure which are subject to federal laws, state laws, and ANSI standards for Suction Entrapment Avoidance.
- The Board's discussion of DS 2012-024 focused on the fact that the existing language of sections 489.105 (3)(f) and (g) F.S. prohibits swimming pools (e.g. pool piping) from all HVAC scopes of work.
- The FSPA agrees with sections 489.105 (3) (f) and (g) clearly prohibiting A/C contractors from working with swimming pool piping and filtration systems. The FSPA understands a heater cannot be installed without interacting with these parts.
- Mr. Tawney commented, based on his 30+ years' experience in the swimming pool heat pump industry as a manufacturer and servicing agent of over 300 models, that heat pumps can have diverse hydraulic characteristics which affect flow rate differently. Thus if the installing contractor is not aware of a particular pump's unique performance calculations, the contractor may very well create what ANSI/APSP-7 considers hazardous conditions.
- A/C contractors are capable of performing repair services on existing swimming pool heat pumps but are not appropriately trained to perform replacements or install brand new heat pumps due to the impacts on plumbing. As such, a consumer would be required to hire a swimming pool contractor for installation/replacement work.
- Public comment: there is a lack of continuing education opportunities to keep contractors up to date with hydraulic system changes over time.
- The importance of knowing the history of a pool's hydraulic system and any changes to the piping in order to appropriately perform work on the system. When the same contractor installs and maintains the pool they already have this knowledge; a new contractor would have to dig up the pipes to properly examine them
- The CDC swimming pool statistics prove death and disembowelment occur as a result of hydraulic entrapment issues more often than electrocution or asphyxiation.
- The USPA supports the legislation excluding "swimming pool piping and filters" from A/C contractors' scope of work.
- Frequency of changing the pump: entirely dependent upon functionality of each unit.
- No substantive motions offered.

Rules Discussion regarding draft language for 61G4-15.001: Qualification for Certification:

#### Comments:

- The difference in the two drafts of the rule, the newer includes "habitable & occupiable" language rather than the older "habitable commercial buildings" language.
- The main update is the addition of the Florida Building Code references
- It was suggested that the word "commercial" needs to remain included in the license language. General Contractors are separated by their exclusive experience with buildings of 4 or more stories, but the word "commercial" it is the only difference between the B and C license language.
- Including the word "aggregate" in (2)(a) under qualifying square footage. There are many aspects to commercial work that residential contractors simply do not encounter. The term

- "aggregate" may allow certain contractors to technically meet commercial criteria without having the full range of experience.
- The major goal of this language cleanup is to clarify what is required because it seems many
  applicants do not fully understand the criteria before applying. However, some feel the
  requirements for a general contractor's license are not restrictive enough which is why financial
  problems arise. Many contractors seem to lack the experience either to perform the work they
  are hired to do or to run a business itself.
- It was noted to take a look at 489.103(3) F.S. exemptions: It would be preferable to simply state, "Paid experience gained under 489.103 will not be allowed".
- Ms. Koning clarified in the corrected language of 1(a) the last sentence reads as follows:
   "However, experience gained through providing services that would fall under an exemption pursuant to Ch. 489 part 1 F.S. will not be accepted".
- On a multi-employer worksite, the experience the subcontractors gain is recognized by the Board because they are working for the primary contractor.
- We need to get back to controlling the means and methods: General Contractor is the only one
  on the job that controls the means and methods. Experience gained under a contractor who
  controls the means and methods.
- Need to be sure experience gained is under a licensed contractor.
- Supervisor is an employee of contractor, or supervisor who is qualified to oversee that scope of work.
- Just for clarification: Rules and Regulations are supplemental to the FS. The statutes under 489.111 paragraphs 2 have a clear description of what is required.
- Contractor can verify relevant experience, relevant scope, Supervisor should be verifying the relevant scope too.
- 489.111 (1)(c)(2)
- This rule purpose is to put people on notice of what to expect when applying and coming before the board.
- The board should have some kind of consensus, amongst the board members itself.
- Add: employed by and appropriately licensed contractor who controls the means and methods of that scope of work on a multi-employer worksite.
- Need to make a reference that experience gained under a subcontractor working for a contractor .... We do need to get subs if they have the relevant experience we just don't need to add supervisory in the language.
- The word supervisor will get misconstrued. We need to think on the language.
- Mr. Dolan would like to have wording to be voted on.
- 2(a) and (3): habitable vs occupiable: this may work if we include a site to reference the Florida Building Code.
- 2(a)(1): should remove the word aggregate
- Ms. Koning: Under 2(a) on her draft: pursuant to the Florida Building Code without reference to chapter 3.
- There should be a (c) under 2(a) that references a Building Contractor.
- The only difference between residential and building is, commercial. If you aren't going to distinguish between the two then do away with the classifications.
- Final Comments: request copies of language tomorrow
- No substantive motions offered.

#### PROSECUTING ATTORNEY'S REPORT – KYLE CHRISTOPHER

Mr. Christopher gave the following report:

For the month of July 2015, the overall license activity case load was 635, down from 682 in June of 2015, and up from 519 in July 2014.

There were 398 cases currently in Legal to be reviewed, 12 cases set for probable cause, 44 cases where probable cause had been found/administrative complaints filed, 0 settlement stipulation approved, 5 informal hearings requested, 0 cases awaiting outside action, 38 cases ready for default, 62 formal hearings requested, 0 cases referred to DOAH, 0 cases in settlement negotiations, 0 case pending board date, 43 cases set for board presentation, 33 cases awaiting final orders, 0 cases under appeal and 0 cases had been re-opened.

For the month of July 2015, 78 cases were closed.

## ATTORNEY GENERAL'S REPORT – Douglas Dolan

## NATHAN ANDERSON - REQUEST FOR INFORMAL HEARING

Mr. Anderson was not present.

Mr. Dolan presented this case stating Mr. Anderson's application for a Certified Gas Line Specialty Contractor's license was denied at the May 2015 meeting of the Board for failure to demonstrate required experienced, as required by Florida Statute 489.111, and 61G4-15.001 Florida Administrative Code. The Notice of Intent to Deny was filed in June of 2015. Mr. Anderson timely requested board reconsideration.

After discussion, the Board vacated the previous denial, and the applicant withdrew.

#### STEPHEN BENDER - PETITION FOR DECLARATORY STATEMENT

Mr. Bender was not present.

Mr. Dolan presented this case stating that Mr. Bender filed a petition for Declaratory Statement on June 11, 2015. The petition was noticed in the Florida Administrative Register on June 19, 2015. Mr. Dolan noted the petitioner asks the Board whether a license is required for an industrial welding contractor in the State of Florida when the welding process is used to repair boilers in petrochemical and power facilities and does not erect, modify, or change any existing structures.

After discussion, the board declined to answer due to the question already being answered.

## **TOMMY BOLES - REQUEST FOR INFORMAL HEARING**

Mr. Boles was present.

Mr. Dolan presented this case stating Mr. Boles filed a Notice of Appeal and Petition for Informal Hearing in this cause on March 6, 2015, and the Amended Notice filed on July 21, 2015. Mr. Boles and Homewise Improvement Solutions, Inc., sought review of the Board Order entered on February 10, 2015, by the Marion County License Review Board of Marion County, Florida. The petitioner filed a notice of appeal pursuant to 489.131(7)(d), FS, and requested the Board conduct a hearing pursuant to Section 120.57(2), FS. The petitioner is requesting an entry of an order by the Board finding that Petitioner is not liable for any additional fine or sanction as recommended by the Marion County License Review Board.

After discussion, the Board voted to reject the recommendation of the Marion County License Review Board and does not impose a penalty on Petitioner in this matter.

# **CHRISTIAN CARDOSO – REQUEST FOR INFORMAL HEARING**

Mr. Cardoso was present.

Mr. Dolan presented this case stating Mr. Cardoso's application to qualify an additional business was denied at the June 2015 meeting of the Board for failure to demonstrate the required experience for a certified class A air conditioning license, pursuant to 489.111 Florida Statutes. The Notice of Intent to Deny was filed in July of 2015. Mr. Cardoso timely requested board reconsideration.

After discussion, the Board voted to vacate the previous denial and approve the application.

#### **KEVIN CLAYTON - REQUEST FOR INFORMAL HEARING**

Mr. Clayton was present.

Mr. Dolan presented this case stating Mr. Clayton's application for a Certified Drywall Specialty Contractors' license denied at the May 2015 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in June of 2015. Mr. Clayton timely requested board reconsideration.

After discussion, the Board voted to uphold the denial.

#### **ROY FLOURNOY – PETITION FOR DECLARATORY STATEMENT**

Mr.Flournoy was not present.

Mr. Dolan presented this case stating that Mr. Flournoy filed a petition for Declaratory Statement on May 5, 2015. The petition was noticed in the Florida Administrative Register on June 19, 2015. Mr. Dolan noted the petitioner asks the Board whether a Certified General Contractor can perform progress/draw inspections on construction projects for financial institutions that are financing the project for the purpose of establishing the status of construction of the project and verifying stored and/or purchased materials.

After discussion, the board voted to decline to answer due to the petition not being legally sufficient pursuant to 28-105.002, Florida Administrative Code.

#### JAMES FREDRICHS - PETITION FOR DECLARATORY STATEMENT

Mr.Fredrichs was present with Counsel.

Mr. Dolan presented this case stating that Mr. Fredrichs filed a petition for Declaratory Statement on May 13, 2015. The petition was noticed in the Florida Administrative Register on June 26, 2015. Mr. Dolan noted the petitioner asks the Board to clarify several definitions within 61G4-15.015, F.A.C. and whether a Specialty Structure Contractor can install preformed panel metal roofs on site built residential or commercial structures where the preformed panel is being installed directly over existing roofing.

After discussion, the board voted to decline to answer due to the petitioner no being substantially affected, as required by section 120.565, Florida Statutes, and the petitioner is not a licensee.

## **ED GUND - PETITION FOR VARIANCE & WAIVER**

Mr. Gund was not present.

Mr. Dolan presented this case stating that Mr. Gund filed a petition for Variance or Waiver on June 4, 2015. The petition was noticed in the Florida Administrative Register on July 16, 2015. Mr. Dolan noted the petitioner asks the Board for a permanent variance or waiver of Rule 61G4-16.005, F.A.C., which

requires for the purpose of certification, a passing grade shall be valid only for a period of four (4) years from the date the list of successful candidate is approved by the Board.

After discussion, the Board voted to deny the petition because the Petitioner has not shown how application of the rule creates a substantial hardship or violates principles or fairness.

## STEVEN HAVEN - REQUEST FOR INFORMAL HEARING
