CHAIRMAN'S REPORT – Chris Cobb

Mr. Cobb informed the board that himself, Mr. Biggins and G.W. Harrell would be attending NASCLA at the end of August and will be giving a presentation at the Conference.

Mr. Cobb would like to request from the Department that each board member get microphones, as well as placing a small American flag at the head of the table.

With nothing further to report the board voted unanimously to approve this report.

PROSECUTING ATTORNEY'S REPORT – Ian Brown

Mr. Brown gave the following report:

For the month of June 2017, the overall license activity case load was 829, up from 794 in May of 2017, and down from 1028 in June 2016.

There were 360 cases currently in Legal to be reviewed, 182 cases awaiting PC Panel/ Initial Review Completed, 4 cases set for probable cause, 45 cases where probable cause had been found/administrative complaints filed, 1 settlement stipulation approved, 6 informal hearings requested, 12 cases awaiting outside action, 29 cases ready for default, 78 formal hearings requested, 1 case referred to DOAH, 23 cases in settlement negotiations, 0 case pending board date, 52 cases set for board presentation, 36 cases awaiting final orders, 0 cases under appeal and 0 cases had been reopened.

For the month of June 2017, 125 cases were closed, this included 22 Final Orders with Discipline.

Mr. Brown recognized, now former Deputy Assistant General Counsel, Clayton Osteen for all of his hard work and dedication to the Department and the Construction Board. He wished him the best from the Department.

With nothing further to report the board voted unanimously to approve this report.

ATTORNEY GENERAL'S REPORT - Rachel Clark

DAVID ABERCROMBIE- PETITION FOR DECLARATORY STATEMENT

Mr. Abercrombie was present

Ms. Clark presented this case stating Mr. Abercrombie filed a petition for declaratory statement on May 2, 2017. The petition was noticed in the Florida Administrative Register on June 15, 2017. Ms. Clark noted the petition seeks the Board's clarification of s.489.105 (3)(p) F.S., specifically whether the pollutant storage systems contractor's license applies to repairing above ground storage tanks.

After discussion, the board voted the petitioner has standing. After further discussion, the board voted to decline to answer the declaratory statement as the answer is already in statute.

RICHARD ANGERHOFER - REQUEST FOR INFORMAL HEARING

Mr. Angerhofer was present.

Ms. Clark presented this case stating Mr. Angerhofer's application for a Certified Mechanical Contractors' license was denied at the September 2016 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in October 2016. Mr. Angerhofer timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application

GISELLE CASTILLO- REQUEST FOR INFORMAL HEARING

TYLER EDWARDS-PETITION FOR DECLARATORY STATEMENT

Ms. Clark noted the petition seeks the Board's clarification of s.489.105 (3)(d), F.S., specifically "whether a certified

sheet metal contractor is authorized to install, maintain, repair, alter, extend, and design ventilate commercial hood systems including ductwork in connection with a complete hood system."

After discussion, the board voted to decline to answer the declaratory statement because the petition because petitioner's request for clarification is vague and facially insufficient, it appears to apply to the conduct of a third party.

ALAN GOESCHEL- REQUEST FOR INFORMAL HEARING

Mr. Goeschel was present.

Ms. Clark presented this case stating Mr. Goeschel's application for a Certified Residential Pool Contractors' license was denied at the April 2017 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in May of 2017. Mr. Goeschel timely requested board reconsideration.

After discussion, the board voted to uphold the denial.

ANTHONY ICAMPO- PETITION FOR VARIANCE AND WAIVER/ REVIEW OF APPLICATION

After discussion, the Board voted to grant the petition and approve the applicant for a Certified Building Contractor's license.

JOHNPAUL MERINO - REQUEST FOR INFORMAL HEARING

Mr. Merino was present.

Ms. Clark presented this case stating Mr. Merino's application for a Certified General Contractors' license was denied at the October 2016 meeting of the Board for failure to demonstrate financial stability and responsibility, pursuant to section 489.115, F.S. and Rule 61G4-15.006, Florida Administrative Code. The applicant has been convicted, found guilty of, or entered a plea of nolo contendere to crimes related to the practice of contracting, contrary to section 455.227(1)© and 489.129 (1)(b), F.S. The Notice of Intent to Deny was filed in December of 2016. Mr. Merino timely requested board reconsideration.
