The Notice of Intent to Deny was filed in June of 2022. Mr. Naranjo timely requested an informal hearing.

After discussion the Board voted to vacate the previous denial and to approve the application.

After discussion the Board to deny the petition as the Board determined that the petitioner was attempting to use the petition as a means to determine the conduct of another person, that there was no controversy or question concerning the applicability of this statute when applied to the petitioner's circumstances, and because the petition presented issues that are substantially similar to those addressed by a previously entered declaratory statement.
