GENERAL SESSION

The meeting was called to order by Robert Moody, Chair, at 9:01am. Mr. Boyette gave the Invocation. Mr. Cobb led the Pledge of Allegiance.

EXECUTIVE DIRECTOR'S REPORT – Drew Winters

Mr. Winters gave the following report:

Mr. Winters distributed the financial reports for the Unlicensed Activity Account, the Construction Industry Licensing Board Operating Account and the Florida Homeowners' Construction Recovery Fund Operating Account.

Mr. Winters informed the Board that the Unlicensed Activity Ad Hoc Committee meeting will be scheduled for the November 2013 meeting, and explained that we did not hold one this month since one was held at the Board's September 2013 meeting in Orlando.

Mr. Winters informed the Board that the Nominating Committee will convene during the November 2013 meeting to nominate the Board Chair and Vice-Chair for 2014. He thanked Mr. Moody for his service as Board Chair, and invited the Board members to provide him with any suggestions for the next Board Chair.

CHAIRMAN'S REPORT - ROBERT MOODY

- Mr. Moody gave the following report:
- Mr. Moody said it was a pleasure serving the Board as the Chair.
- Mr. Moody introduced, and welcomed, new Board members Ben Dachepalli and Andrew Allocco.

Mr. Moody updated the Board on the development of the demolition specialty contractor's examination. Mr. Moody stated that they are currently working with PSI to develop the test item bank, and asked that the Board members offer assistance, if possible.

With nothing further to report the board voted unanimously to approve this report.

PROSECUTING ATTORNEY'S REPORT – KYLE CHRISTOPHER

Mr. Christopher gave the following report:

For the month of September 2013, the overall license activity case load was 371, up from 350 in August of 2013, and up from 343 in September 2012.

There were 139 cases currently in Legal to be reviewed, 22 cases set for probable cause, and 51 cases where probable cause had been found/administrative complaints filed. 0 settlement stipulations had been approved, 0 informal hearings had been requested, and 9 cases were awaiting outside action. 6 cases were ready for default, 14 had requested formal hearings, and 0 cases were referred to DOAH. 5 cases were in settlement negotiations, 1 case was pending a board date, and 52 cases were set for board presentation. 72 cases were awaiting final orders. 0 cases were under appeal and 0 cases had been reopened.

For the month of September 2013, 46 cases were closed.

For the month of September 2013, the overall unlicensed activity case load was 251.

There were 213 cases currently in Legal to be reviewed, 20 cases where administrative complaints has been filed, 0 settlement stipulations approved, 2 informal hearings requested, 0 cases awaiting outside action, 11 cases ready for default, 4 formal hearings requested, 0 cases referred to DOAH, 1 case in settlement negotiations, 0 cases awaiting final orders, 0 cases under appeal and 0 cases had been reopened.

With nothing further to report the board voted unanimously to approve this report.

ATTORNEY GENERAL'S REPORT - TOM BARNHART

JOEPY CORTEZ - REQUEST RECONSIDERATION

Fred Dudley, Esq., counsel for Mr. Cortez was present.

Mr. Barnhart presented this case stating Mr. Cortez' application to qualify an additional business was denied at the August 2013 meeting of the board for failing to demonstrate the qualifying agent would properly supervise the construction work and business activities, as required by section 489.119, Florida Statutes. The Notice of Intent to Deny was filed in September of 2013. Mr. Cortez timely requested board reconsideration.

After discussion the board voted to vacate the denial of the application and allow the application to be withdrawn.

PHILIP ECKHOFF - REQUEST FOR INFORMAL HEARING

Mr. Eckhoff was present.

Mr. Barnhart presented this case stating Mr. Eckhoff's application for initial issuance of a certified building contractor's license was denied at the July 2013 meeting of the board for failing to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code and failing to sufficiently demonstrate financial stability and responsibility, pursuant to section 489.115, Florida Statutes and Rule 61G4-15.006, Florida Administrative Code. The Notice of Intent to Deny was filed in August of 2013. Mr. Eckhoff timely requested board reconsideration.

Mr. Eckhoff requested a 90 day continuance of this hearing to provide lien satisfaction. After discussion, the board voted to grant the continuance.

LARRY GARBER - REQUEST FOR INFORMAL HEARING

Mr. Garber was present with counsel.

Mr. Barnhart presented this case stating Mr. Garber's application for initial issuance of a certified general contractor's license was denied at the July 2013 meeting of the board for failing to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code and failing to sufficiently demonstrate financial stability and responsibility, pursuant to section 489.115, Florida Statutes and Rule 61G4-15.006, Florida Administrative Code. The Notice of Intent to Deny was filed in August of 2013. Mr. Garber timely requested board reconsideration.

Mr. Garber requested a 90 day continuance of this hearing to provide experience and financial documentation. After discussion, the board voted to grant the continuance.

NILO HERNANDEZ – PETITION FOR VARIANCE AND WAIVER

Mr. Hernandez was not present.

Mr. Barnhart presented this case stating Mr. Hernandez filed a petition for variance and waiver on August 16, 2013. The petition for variance and waiver was noticed in the

Florida Administrative Register on September 23, 2013. Mr. Barnhart noted the petitioner seeks clarification as to whether he can grandfather his County Roofing certificate or License into a Certified Roofing License, pursuant to Section 489.118, Florida Statutes. Mr. Barnhart asked the board to consider the petition and grant or deny the waiver as required.

After discussion the board voted to deny the petition.

MARK HICKINBOTHAM – PETITION FOR DECLARATORY STATEMENT

Mr. Hickinbotham was not present.

Mr. Barnhart presented this case stating Mr. Hickinbotham filed a petition for a declaratory statement on August 15, 2013. The petition was noticed in the Florida Administrative Register on August 29, 2013. Mr. Barnhart noted the petition seeks the Board's interpretation as to whether a certified general contractor is licensed to perform the same scope of work as a PCC, and whether a certified general contractor can furnish and install chemical feed systems without a PCC, CMC or CFC license.

Mr. Barnhart asked the board to consider whether or not the petition meets the criteria for a declaratory statement, and to dismiss or answer as appropriate.

Mr. Hickinbotham requested a 30 day continuance of this hearing. After discussion, the board voted to grant the continuance.

PATRICK HIGGINS - REQUEST FOR RECONSIDERATION

Mr. Higgins was present with counsel.

Mr. Barnhart presented this case stating Mr. Higgins' application for initial issuance of a certified general contractor's license was denied at the July 2013 meeting of the board for failing to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in August of 2013. Mr. Higgins timely requested board reconsideration.

Mr. Higgins requested that the Board consider approving his request to downgrade to the certified building contractor's license. After discussion, the board voted to uphold the denial and not grant the downgrade request.

DANEX LOZANO - REQUEST FOR INFORMAL HEARING

Mr. Lozano was present.

Mr. Barnhart presented this case stating Mr. Lozano's application to qualify an additional business was denied at the August 2013 meeting of the board for failure to appear, pursuant to Rule 61G4-15.0021, Florida Administrative Code. The Notice of Intent to Deny was filed in September of 2013. Mr. Lozano timely requested board reconsideration.

After discussion the board voted to vacate the previous denial, but deny the application because the applicant did not demonstrate the qualifying agent would properly supervise the construction work and business activities, as required by section 489.119, Florida Statutes.

LUIS MORA - REQUEST FOR INFORMAL HEARING

Mr. Mora was not present.

Mr. Barnhart presented this case stating Mr. Mora's application for initial issuance of a certified plumbing contractor's license was denied at the May 2013 meeting of the board for failing to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in May of 2013. Mr. Mora timely requested board reconsideration.

After discussion, the board voted to uphold the previous denial.

UTILITY SERVICE COMPANY INC - PETITION FOR DECLARATORY STATEMENT

Representative from Utility Service Company Inc was present.

Mr. Barnhart presented this case stating Utility Service Company Inc filed a petition for a declaratory statement on July 31, 2013. The petition was noticed in the Florida Administrative Register on September 19, 2013. Mr. Barnhart noted the petition seeks the Board's clarification of the scope of work for the tower specialty license. Mr. Barnhart asked the board to consider whether or not the petition meets the criteria for a declaratory statement, and to dismiss or answer as appropriate.

After discussion the board voted the petitioner had the proper standing. After further discussion the board voted that the services, as described in the petition, fall under the scope of their present tower specialty license classification. The services were described as:

THM Removal System Installation – The THM Removal System installation typically consists of installing a centrifugal pump at the base of the water storage tower/tank, installing welded steel piping from the pump location to the top of the water storage tank, and installation of spray nozzles and air vents in the roof of the tank. All of these items are purchased by the tank owner as a package which we then install on their existing water storage tower/tank on their behalf. These installations may include a 10ft x 10ft or smaller pre-fabricated shed or pump house for the pump. All electrical work is completed by the tank/tower owner via a subcontract with a certified electrician.

CHARLES WEBSTER - REQUEST FOR INFORMAL HEARING
