ABBAS, OMAR - REQUEST FOR INFORMAL HEARING

Mr. Abbas was present with counsel

Mr. Barnhart presented this case stating Mr.Abbas' application for a Certified General Contractor's license was denied at the September 2019 meeting of the Board for failure to demonstrate the required experience, pursuant to section 489.111, Florida Statutes, and Rule 61G4-15.001, Florida Administrative Code. The Notice of Intent to Deny was filed in October of 2019. Mr. Abbas timely requested board reconsideration.

After discussion, the board voted to vacate the previous denial and approve the application as a downgrade to a Certified Building Contractor.
