The meeting was called to order by Paul Del Vecchio, Chair, at approximately 8:04 a.m. Mr. Stewart gave the invocation and Mr. Del Vecchio led the Pledge of Allegiance.

REVIEW OF MINUTES

• Final Action – August, 2006

The board voted unanimously to approve these minutes.

EXECUTIVE DIRECTOR'S REPORT

Mr. Harrell reported that 93% of the certified contractors were in compliance with the required continuing education credits and the renewal process.

CHAIRMAN'S REPORT

Mr. Weller and Mr. Thornton's absences were excused.

PROSECUTING ATTORNEY'S REPORT

Mr. Creehan gave the following report:

As of August 2006, there were 399 cases in Legal, 194 cases set for Probable Cause, 300 cases had probable cause found/Administrative Complaints found and 163 were ready for Default. There were 164 cases with Stipulations executed/Informal Hearings requested, 133 cases with Formal Hearings requested and 6 cases were referred to DOAH. There were 81 cases awaiting Final Orders, 22 cases in settlement negotiations, 0 cases under Appeal and 0 cases was reopened.

The board voted unanimously to ratify the Local Disciplinary Orders pulling A4.

ATTORNEY GENERAL'S REPORT

Advanced Builders College, Inc. - Request for Informal Hearing

No one was present.

Ms. Guillemette presented this case stating that these applications were denied at the June meeting of the Board. The Notice of Intent to Deny was received on July 10, 2006.

The request for review was timely filed.

After discussion, the Board voted unanimously to uphold the ruling of the Continuing Education Committee.

Florida International University – Request for Informal Hearing

No one was present.

Ms. Guillemette presented this case stating that this application was denied at the May meeting of the Board. The Notice of Intent to Deny was received by applicant on June 26, 2006. On July 20, 2006 a Petition for Appeal Hearing was filed.

After discussion, the board voted unanimously that the Petition was untimely.

HornerXpress – Request for Informal Hearing

This request was withdrawn.

Todd Johnson – Request for Informal Hearing

Mr. Johnson was present.

Ms. Guillemette presented this case stating that Mr. Johnson's application was denied at the February meeting of the Board. The denial was based on Mr. Johnson's failure to appear.

After discussion, the board voted unanimously to send Mr. Johnson's application back to the October Additional Business Committee Meeting.

Heather Dawn Michael – Request for Informal Hearing

Ms. Michael was present with Attorney Jennifer O'Barr.

Ms. Guillemette has requested that the Board consider reinstating her null and void license under the new provision of 455.271, Florida Statutes.

The Board found that the Petitioner failed to present evidence of a good faith effort to comply with the license renewal and failed to present evidence which rose to the level of illness or unusual hardship.

After discussion, the board voted to deny Ms. Michael's request.

Rickey Morgan - Request for Informal Hearing

Mr. Morgan was present for this hearing.

Mr. Morgan asked the board to continue this case so that he could be represented by an attorney.

The board voted unanimously to continue this case until the January 2006 meeting.

National Roofing Contractors – Request for Informal Hearing

Ms. Jean Schehl was present for this case.

Ms. Guillemette presented this case stating that the National Roofing Contractor's Association's application for continuing education credit for the course "Specright: Energy – Efficient Roof System Design" was denied at the June meeting of the board.

After discussion the board voted unanimously to approve this course.

Tampa Bay Pipe Trades JATC – Request for Informal Hearing

This was approved at the September 14, 2006 Continuing Education Committee meeting.

Robert Fleming – Request for Early Termination of Probation

Mr. Fleming was present for this case.

Ms. Guillemette presented this case stating that Mr. Fleming's application was conditionally approved with probation until his civil rights have been restored in summer 2003.

Mr. Fleming is requesting early termination of his probation.

After discussion the board voted unanimously to terminate Mr. Fleming's probation.

At the August meeting the Rules Committee changed the language making the bond reliant on the lifetime cap.

Ms. Rodgers and Ms. Guillemette feel that the citizens of the state may be better served by the first draft of the change.
