FINAL ORDER

This matter came before the Construction Industry Licensing Board (Board) pursuant to section 120.565, Florida Statutes. At a duly-noticed public meeting held on November 11, 2011 in Fernandina Beach, Florida, the Board considered the Petition for Declaratory Statement filed by PAUL J. DEL VECCHIO, who was present.

The Petition was filed with the Department of Business and Professional Regulation on October 18, 2011. Notice of the Petition was published on November 4, 2011, in the Florida Administrative Weekly. No comments were received.

Having considered the Petition and relevant statutes and rules, the Board issues the following:

FINDINGS OF FACT:

1. The facts considered by the Board are as alleged in the Petition, a copy of which is attached hereto and incorporated by reference, and presented at the

meeting, with no further investigation by the Board.

2. Petitioner is licensed by the Board as a certified general contractor.

3. Petitioner asks the Board whether Construction Management as a service that oversees the management of construction activities on a given project is the exclusive purview of a licensed contractor, or whether this service can be performed by an unlicensed individual or entity.

CONCLUSIONS OF LAW

4. The Construction Industry Licensing Board has authority to issue this Final Order pursuant to Section 120.565, Florida Statutes, and Rule 28-105, Florida Administrative Code.

5. Petitioner is substantially affected, as required by section 120.565, Florida Statutes.

6. Pursuant to section 489.105(3), Florida Statutes, a license is required to contract to perform construction.

Therefore, the Board hereby issues a declaratory statement that Construction Management as a service that oversees the management of construction activities on a given project is the exclusive purview of a licensed contractor. Further, construction management, as described herein, cannot be performed by an unlicensed individual or entity.

This Final Order shall be effective upon filing with the Clerk of the Department of Business and Professional Regulation.
